In continuation to this Office Notice No. 7339/PSC, dt. 15.11.2019 it is for information of all concern candidates are directed to appear at the verification of Original Documents for recruitment to the post of Odisha Civil Services Examination-2018, pursuant to advt. No. 05 of 2018-19 as per programme mentioned at Annexure-A. The candidates are directed to submit hard copy of "Online Application" form alongwith "Intimation letter", "Attestation form", "Bio-data form" and "Declaration format" download from the website of the Commission and duly filled by the candidate and produce the same for admission to verification of documents.

It is also made clear that, the candidature of these candidates for this recruitment is purely provisional and subject to fulfillment of terms and conditions laid down in the advertisement. The candidature is liable to rejection in the event of inadequacy/deficiency found at any stage before or after the verification of document/ Personality Test.

The candidate are also required to bring all the Original Documents alongwith a set of true copies of the following documents duly self attested mentioning on each documents "submitted by me" and put their full signature and date on the same, failing which he/she shall not be allowed to verification of documents or to appear at the personality test or interview.

## List of Original Documents to be furnished in the following order

- 1. Hard copy of online application form duly signed by candidates in the declaration part.
- 2. Attestation Form, Bio-Data & Declaration Format duly filled in (To be downloaded from the website of the Commission).
- 3. H.S.C. Or Equivalent Certificate in support of Declaration of Age issued by the concerned Board/Council.
- 4. Intermediate/+2 Examination Certificate issued by the concerned Board/Council.
- 5. Bachelor's Degree Certificate issued by the concerned University.
- 6. If a candidate claims to posses qualification, equivalent to the prescribed qualification, the rule/authority (with number & date) under which it is so treated, must be furnished with the hard copy of the online Application.
- 7. Required Odia Pass Certificate.
- 8. Aadhaar Card in Original and it's photocopy duly attested by the candidate.
- 9. Caste Certificate by Birth in support of claim as SC/ST, wherever applicable (Caste Certificate by virtue of marriage is not accepted).
- 10. Candidates of SEBC category (other than Creamy Layer) must have to submit Caste Certificate by birth issued by the Competent Authority (issued within 3 years), (Caste Certificate by virtue of marriage is not accepted). OBC Certificate will not be accepted in lieu of SEBC Certificate.

- 11. Caste Certificate of SC/ST/SEBC candidates must be same & tallied as per filled up in online application form.
- 12. OPSC copy of challan showing payment of examination fee (Pay in slip) for payment of fee at SBI.
- 13. A declaration regarding number of attempts exercised by the candidates in the OCS Examination in the format annexed at Annexure-B.
- 14. In case of Sports Person candidates: Identity card issued by Director of Sports, Odisha.
- 15. In case of PWD candidates: Disability Certificate (Indicating percentage of permanent disability, i.e. more than 40%) issued by the concerned Medical Board, wherever applicable.
- 16. In case of Ex-Servicemen candidates: Discharge Certificate issued by the Commanding Officer of the Unit Last served/Identity Card issued by Rajya Sainik Board or Zilla Sainik Board in original.
- 17. The Ex-Servicemen candidates are required to furnish an Affidavit in original indicating that-

"I have not got any appointment as an Ex-Serviceman against Civil Post against the Quota available for the said category".

#### OR

Certificate in Original issued by the Employer/Controlling Authority showing the Date of Joining in the Civil Post/Service in the Government Job on the civil side availing the Ex-Servicemen benefit.

#### OR

An Affidavit in Original showing the Date of Joining in the service availing Ex-Servicemen benefit.

- 18. If a candidate claims to posses qualification, equivalent to the prescribed qualification, the rule/authority (with number & date) under which it is so treated, must be furnished.
- 19. Certificate of good character from Principal/Proctor/Dean or Professor in charge of Department of Teaching of the College or University/Institution in which last studied.
- 20. Two recent passport size photographs with signature on its front, which has been uploaded with online application form.
- 21. No Objection Certificate (in case of in-service candidates), wherever applicable.
