**TGT (MATHS) MALE, POST CODE-133/17 IN DIRECTORATE OF EDUCATION.**

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total 286 [UR-170, OBC-55, SC-42, ST-19, including PH (OH-04, VH-05)] vacancies for the post of **TGT (Maths) Male, Post Code-133/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in online computer based examination mode was conducted on **23/09/2018**.

2. On the basis of online examination of Tier-1 held on **23/09/2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (Maths) Male, Post Code-133/17** in Directorate of Education, a total of **72 (UR-50, OBC-04, SC-18, ST-Nil)** candidates were provisionally nominated for the post of **TGT (Maths) Male, Post Code-133/17** vide Result Notice No. **420** dated **30.04.2019** and the candidature of **07 candidates** (UR-02, OBC-01, SC-04 including PH/OH-01) was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. **02.05.2019 to 11.05.2019** and **02 candidates** under OBC category were kept pending for verification of their OBC (Delhi) status.

3. Out of 07 pending candidates whose candidature was kept pending for want of deficient documents / clarification, 06 candidates have uploaded the requisite documents / during the period **02.05.2019 to 11.05.2019** and found eligible as per RRs. Further, 02 candidates under OBC category which have been kept pending for verification of their OBC (Delhi) status are also being nominated for thorough verification regarding their OBC (Delhi) status at the level of the user department.

4. (i) Accordingly, in continuation to Result Notice No. **420** dated **30.04.2019**, the candidates, as detailed below, are also provisionally selected on the basis of online examination of Tier-1 held on **23/09/2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (Maths) Male, Post Code-133/17** in Directorate of Education.

5. The selection of the above candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The decision of the User Department regarding the eligibility of the candidate shall be final and binding on the candidate.

6. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates.

7. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013.

8. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

9. The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.

10. The candidature of the following 01 (one) candidate has been kept pending due to the reasons mentioned against his roll no.:-

11. The above pending 01 candidate i.e. having Roll No. 120213301454 is directed to upload his pending document as mentioned above through the e-dossier module in stipulated time failing which his candidature will be rejected without any further notice.

The above candidate is also being separately informed through, SMS on his registered mobile number. **If the candidate fails to upload required document through e-dossier during the above said period his candidature will be rejected and no further opportunity for uploading in the e-dossier will be given on whatsoever ground.**

13. The result process for the above post code stands closed in all respect except 01 pending cases as referred above.

14. A waiting panel has been prepared and shall be valid for one year from the date of declaration of result i.e. upto 29.04.2020 as per earlier result notice no. 420 dated 30.04.2019.



15. Mere inclusion of name in the result notice does not confer any right upon the candidate over the post.
