1. This requirement is only for "Trade Apprenticeship" engagement on stipend basis.

Note : Candidates who have already undergone or are currently undergoing apprentice training under the apprentice Act, 1961 in any Central/State Government or Public Sector Undertaking or any Private organization are not eligible to apply.

1. The candidates should possess the required physical standard as below :

Height	137 cm
Weight	25.4 Kg
Chest measurement	Expansion should not be less than 3.8. cms (Irrespective of size of chest).
Vision	There should be no evidence of any morbid condition of either eye and the lids of either eyes which may be liable to risk or aggravation or recurrence.

2. The minimum age of the applicants as on **21<sup>st</sup> January, 2020** should not be below 16 years for all candidates and maximum age upto 24 years for General/EWS candidates. Relaxation upto 5 years for SC/ST candidates, 3 years for OBC candidates and 10 years for PwBD candidates would be given as per the Govt. of India Directives.
3. Interested candidates are first required to register in the web portal <http://apprenticeship.gov.in> for enrolment as apprentices. The applications will not be accepted without registration in the above mentioned web portal.
4. Those who have enrolled for apprenticeship in the web portal <http://apprenticeship.gov.in>, have to apply for the respective trade through the Establishment Registration No. **E06172702965**, the establishment id for Nuclear Power Corporation of India Ltd, Tarapur Maharashtra Site. The applications will not be accepted, if not applied in the Establishment ID.
5. The following documents/certificates are required to be uploaded alongwith the online application for short listing for engagement of apprenticeship training.
- Upload Photo and Signature.
  - Upload Aadhar Card
  - Upload ITI Passed marksheets of all Semesters (To be scanned in vertical mode in one PDF file and upload)
  - Upload Certificate - SC/ST/OBC/EWS/PwBD (if applicable)

6. **Stipend during Apprenticeship :**

- 90% of the minimum wage for semi-skilled worker notified by the Govt., of Maharashtra, if he/she had undergone 2 years ITI training course.
- 80% of the minimum wage for semi-skilled worker by the Govt. of Maharashtra, if he/she had undergone 1 year ITI training course.

7. **Duration of Apprenticeship Training**

The period of Apprentice training will be for one year only.
