Dear Candidate,

After being shortlisted for document verification for various posts of JE/DMS against CEN-03/2018, you appeared for document verification in the office of Railway Recruitment Board, Bhubaneswar, which was followed by a medical examination at the Railway Hospital.

However, as per the medical report received from the Railway hospital, you were not found fit in the prescribed medical category by the three member medical committee. The remarks given by the hospitals regarding the medical fitness are indicated against your names.

As per the instructions contained in East Coast Railway's letter No. ECoR/BBS/MED/04(C)/ Policy/RME(A)/3752 Dated 09.04.2018, you have an option to appeal against this verdict of the Railway Medical Committee.

The procedure of appeal is as follows:-

- i) If the candidate wants to appeal against the decision of the medical committee, he should submit the appeal to the Principal Chief Medical Director of East Coast Railway within a period of one month from the date of issue of this letter. This appeal addressed to the Principal Chief Medical Director, East Coast Railway, Bhubaneswar should reach at the following address by speed post or delivered by hand.

- ii) Such an appeal shall be entertained, only if, the candidate produces a medical certificate from a Government/private doctor of the specialty/specialties in which the candidate has been found unfit.
 - (a) Such certificate should contain a note that "The Government/private specialist is fully aware of the physical and visual standards set by the Railway for the particular medical category, and that he/she is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate medical board comprising of three senior Railway doctors appointed by the Government in this regard".
 - (b) The certificate should bear the photograph and mark of identifications of the candidate duly attested by such a Government/private issuing authority. Such an issuing authority shall also clearly mention his/her full name, designation, address etc. and his/her Medical Council of India/State registration number.

If you wish to appeal against this medical verdict, kindly send your appeal as indicated above to Railway Recruitment Board, Bhubaneswar **by 23.01.2020** with the following three documents.

- a) **Appeal with justifications duly signed by the candidate indicating his/her Roll No., Registration number & date of document verification.**
- b) **Medical certificate issued by Government/private specialist as per the format enclosed as Annexure-A.**
- c) **A demand draft for Rs.1000/- (Rupees one thousand only) in favour of FA & CAO/East Coast Railway/Bhubaneswar.**

Enclosed: (a) List of 35 candidates who attended document verification **from 18.11.2019 to 29.11.2019** but were not found fit in prescribed medical category. The list is arranged in ascending order of roll numbers.
