**SUB : Instructions to PWD candidates qualified for Skill Test/Typing Test for the post of Jr. Judicial Assistant scheduled to be held on 21.01.2020.**

It is to bring into notice of the candidates who qualified for Skill Test/Typing Test for the post of Junior Judicial Assistant under PWD category, the following instructions:-

1. Candidates in the category of Visually Handicapped will be granted 30 minutes time for the Skill Test/Typing Test instead of 10 minutes. The candidates may bring their own Scribe/Reader so as to narrate the typing passage for SkillTest/Type Test". No Scribe/Reader shall be provided by the office.
2. The candidates belonging to PH-ORS category claiming exemption from Skill Test/Typing test due to physical disability in both hands or due to cerebral palasy or other reasons shall submit a certificate from Medical Board attached to Special Employment Exchanges for the handicapped (or by a Civil Surgeon where there is no such Board) declaring him/her to be permanently "unfit" for the typing test. The certificate shall be submitted on the day of Skill Test/Typing Test i.e. 21.01.2020 at the respective centre or within seven days from the day of Skill Test/Typing Test at Room NO. 306-B, Recruitment Cell, Tis Hazari Courts, Delhi.
3. No exemption shall be given to the candidates falling under the PH-Hearing Handicapped category.
