Corrigendum to the Advertisement No. 02/20 & 04/20.

Kind attention of the applicants is invited towards the various teaching posts (Post Code- 19/20 to 36/20 advertised vide advertisement No. 02/20) & (Post codes 64/20 to 93/20, advertised vide advertisement No. 04/20), under Directorate of Education.

1. The age relaxations to guest / contract teachers as mentioned in the above said advertisements against Advt. No. 02/20 & 04/20, Post Codes 19/20 to 36/20 and 64/20 to 93/20 under heading 'Age limit' may be read as:

"Guest/Contract teachers:- Relaxation in upper age as a onetime measure up to the actual time spent as contractual employee of the same department (i.e. Directorate of Education), subject to a maximum of 5 years provided they have worked for at least 120 working days in that particular year as per Services Department letter/circular No. F.19(11)/2015/S-IV/1751-1756 dated 11/06/2019. The Guest /Contract teachers who have already availed one time age relaxation earlier, will not be entitled for this age relaxation."

Instead of:

"Guest/Contract teachers:- Relaxation in upper age as a onetime measure up to the actual time spent as contractual employee of the same department, subject to a maximum of 5 years provided they have worked for at least 180 working days in that particular year as per Services Department letter/circular No. F.19(11)/2015/S-IV/1751-1756 dated 11/06/2019."

2. For the post of Special Education Teacher, Post Code 93/20, Advt. No. 04/20, the following categories of candidates will also be eligible for age relaxation:-
