**POSTS INCLUDED IN THE
COMBINED ENGINEERING SERVICES EXAMINATION**

After verifying the certificates uploaded by the candidates during the period from 20.11.2019 to 29.11.2019 in support of the claims made in the online applications, the list of Register Numbers of candidates admitted provisionally to the Oral Test for the **POSTS INCLUDED IN COMBINED ENGINEERING SERVICES** was published in the Commission's website on 19.12.2019 based on the results of the written examination conducted by the Commission on 10.08.2019 and 25.08.2019.

The application of the candidate with register number 200001068 which was rejected initially has since been admitted provisionally since the candidate has produced evidence for date of publication of UG results.

As the candidate has completed the prescribed qualification before the date of notification, it has been decided to admit the candidate with register number 200001068 provisionally to Oral Test being held in the Office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai – 600 003. The candidate should attend the Oral Test with all original certificates in support of the claims made in her online application. **Individual Communication regarding the date and time of Oral Test will not be sent to the candidate by post. The above details will be made available in the Commission's Website and Candidate will be informed of the above fact only through SMS and e-mail accordingly.**

Notes:

1. Mere inclusion of the Register Numbers of candidates in the above list will not imply that their candidature has been fully considered for next stage of selection.
2. The candidates whose Register Number is found in the above list have been admitted provisionally to the Oral Test based on the marks obtained by her in the Written Examination and with reference to rule of reservation of appointments. The admission of the candidate to the Oral Test is provisional subject to the verification and acceptance of the claim in her online application towards age, educational qualification, experience, community, Differently abled category, PSTM etc., through original documents. If any of her claims are found to be false or incorrect, her provisional admission to Oral Test will be cancelled and she will not be admitted to the next stage of selection.
3. The admission of the above candidate to the Oral Test is purely provisional subject to the decision of the Commission and subject to the outcome or final orders in WMP(MD)Nos. 9982/2019 & 9983/2019 in WP(MD)No. 13408 of 2019, and other cases/WPs relating to this recruitment, pending on the files of the Hon'ble High Court, Madras / Madurai Bench of Madras High Court.
4. The above said candidate is hereby advised to attend the Oral Test with all the relevant documents in original, without fail. Failure to produce even any one of the essential documents will result in her non-admission to the Oral Test.
