It is hereby informed that he/she has been admitted provisionally to the Oral Test (Interview) for the selection of candidates for appointment by direct recruitment to the posts included in the Combined Engineering Services Examination, 2008-2020 subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in W.P.No.52/2020.

- 2. He/she is, therefore, directed to present himself/herself for the Oral Test for the said post on the designated date and time as mentioned above, at the Office of the Tamil Nadu Public Service Commission, TNPSC Road, Chennai 600 003 (Near Chennai Fort Railway Station and Broadway Bus Terminus). He/She should produce all the original documents along with two sets of photocopies in respect of all the claims made by him/her in the Online application. Apart from that, if he/she fails to produce any one or more of the following documents in original, he/she will not be admitted to the Oral Test under any circumstances and also he/she is liable to lose his/her chance of being interviewed:-
- i. Evidence of Date of Birth (SSLC/HSC).
- ii. Evidence of educational qualification (as on 29.05.2019) as mentioned in para.4(B) of the Commission's Notification dated 29.05.2019.
- iii. Persons claiming to possess equivalence of qualification should produce the evidence in the form of G.O. issued prior to the date of notification for this recruitment. Failing which their application will be summarily rejected.
- iv. Evidence of Qualification in Tamil: One must have passed the S.S.L.C. examination or its equivalent examination with Tamil as one of the languages or studied the High School Course in Tamil Medium and passed the S.S.L.C. examination or its equivalent examination in Tamil Medium or passed the Second Class Language Test in Tamil conducted by the Tamil Nadu Public Service Commission. [Explanation (i) under Section 21(1) of the Tamil Nadu Government Servants (Conditions of Service) Act 2016].

- v. The candidates who have claimed PSTM (i.e., Persons Studied in Tamil Medium) in the online application should produce evidence for having studied the prescribed qualification in Tamil Medium and the certificate obtained from the Principal of the Institution where he had undergone the above said degree. Candidates who had studied in the Distance Education should produce the Certificate obtained from the Registrar of the University concerned.
- vi. Community Certificate with Father's name from the competent authority as specified in para.15 (f) of the Commission's Instructions to Applicants.
- vii. Evidence for religion (Community Certificate / Transfer Certificate).
- viii. In respect of Differently Abled candidates, proper certificate of Physical Disability obtained from the Medical Board concerned in the relevant specialty, specifying the nature of physical Disability, the degree of disability.
- ix. In respect of <u>Destitute Widow candidates</u>, who have made claim in the application, Destitute Widow Certificate obtained from the Revenue Divisional Officer of the concerned District in the prescribed format.
- x. In respect of <u>Ex-Servicemen candidates</u>, proper certificate of evidence for having claimed as an Ex-Serviceman with required particulars in the prescribed format (as stipulated in Para 13 of the 'Instructions to Applicants') duly authenticated by the District Ex-Serviceman Welfare Officer. Evidence for drawing pension (Pension Payment Order) and Ex-Serviceman Book should also be produced.
- xi. No Objection Certificate in case of candidates who are in Government Service / Undertakings in the format as prescribed in para.15(g) of the Commission's Instructions to the Applicants. If punishment is imposed or charges are pending the copy of orders or charge memo should be produced.
- xii. Experience certificate: Applicant who posses practical experience in large electricity supply undertakings or the Tamil Nadu Electricity Board including experience in design office for a period of not less than three years should produce proper Experience certificate as prescribed in Annexure- 1 format of the Commission's Notification.
- xiii. A photocopy of all the above documents should also be kept ready for producing them, if necessary.
- xiv. <u>Two copies</u> of recent passport size photographs.
- xv. A printout of this memorandum showing the date of oral test should be produced at the time of oral test

Notes: -

- 1) The Instructions underlined in paragraph (2) above will be strictly enforced.
- 2) The admission of the candidates to the Oral Test is purely provisional subject to verification and acceptance of his/her claim in his/her online application towards age, educational qualification, religion, community etc. If any of his/her claim is found to be false or incorrect, he/she will not be admitted to the Oral Test.
- 3) He/She is also informed that his/her admission to the Oral Test is purely provisional subject to the decision of the Commission and also subject to the outcome of cases, if any, pending on the files of the Hon'ble High Court of Madras / Madurai Bench of the Madras High Court, relating to this recruitment.
- 4) The candidate will not be admitted to the Oral Test, if he/she presents himself/herself half an hour late after the scheduled time specified above.
