Instructions for filling online Scrutiny form:

1. Click on “Fill Scrutiny form for the post of Clerk” on the website of HSSC ie. hssc.gov.in.
2. Fill the required fields as per original documents. It is mandatory for the candidates to fill all the fields and upload original documents which are applicable to candidates.
3. **Take a printout after final submission of form. Before uploading the documents, candidate shall number the documents and shall mention total number of pages and total number of documents uploaded in the scrutiny form.**
4. Bring the signed scrutiny form with all original documents and application form at the time of document verification.
5. On the top of scrutiny form serial no, Time slot, committee allotted to candidates will be mentioned and the candidates shall come accordingly.
