Provided that where an appointing authority is satisfied that a person having an experience specified above is not available for promotion and that it is necessary in the public interest to fill up the post by promotion of a person having experience for a lesser period; it may, for reasons to be recorded writing, promote such person who has experience for a period not less than two thirds of a period specified above; or

- (b) by direct selection on the basis of the result of the competitive examination held by the Gujarat Public Service Commission:
- 3. Appointment by direct selection and by promotion shall be made in the ratio of 1: 4 respectively.
- 4. To be eligible for appointment by direct selection to the post mentioned in rule 2, a candidate shall --
  - (a) not be more than 30 years of age;
  - (b) possess Bechelor's degree in law of any of the Universities established by an Act of Parliament or the State Legislature or any educational institution established by an Act of Parliament or declared to be deemed as a University under Section 3 of the University Grant Commission Act, 1956.
- 5. The candidate appointed by direct selection shall be required to pass the departmental examination and an examination in Gujarati or Hindi or both in accordance with the rules

prescribed by the Government in that behalf from time

6. The candidate shalk be on probation for a period of two years:

- 7. The selected candidate shall be required to undergo pre-service training and to pass the pre-service training examination as may be prescribed by the Government in that behalf from time to time.
- 8. The candidate appointed either by direct selection or by promotion shall have to undergo such training as may be prescribed by the Government from time to time.
- 9. The selected candidate shall be required to furnish surety and security bonds for such amount and for such period and in such form as may be prescribed by the Government.
