The candidates provisionally admitted for verification of certificates are required to produce the Original Certificates at the time of verification of documents, relating to **Age (SSC), proof of age relaxation, Qualifications, Study certificate, Integrated Community certificate in case of reserved candidates, certificate of exclusion from Creamy layer in case of B.Cs** from Revenue authorities in terms of G.O. Ms. No.3, Backward Classes Welfare (C-2) Department, dt.04/04/2006 and G.O.Ms.No.26, BC Welfare (C) Dept., dt.09/12/2013, **P.H. certificate in case of disabled candidates, migration certificates for candidates who migrated from Telangana to Andhra Pradesh etc.**, failing which, they will not be treated as eligible with reference to the particulars furnished by him/her in the Online application form / Certificates. The results of such candidate(s) shall be cancelled at any stage in the process of selection. The Commission has the right to disqualify any candidate, if he/she is not found eligible for any reason. Candidates are directed to download the call letter, Two (2) checklists and Two (2) Attestation forms from the Commission's website [www.psc.ap.gov.in](http://www.psc.ap.gov.in).
