The above details will be made available in the Commission's website and candidates will be informed of the above fact only through SMS and e-mail. Failure to upload even any one of the essential documents will entail summarily rejection of his/her application. Any false claim made by the candidate will be viewed seriously and the candidate is liable for penal action to be initiated by the Commission besides rejection of the application.

- the candidates who have secured the same marks as that of the cut-off marks, have also been admitted to the Main Written Examination though the number of candidates exceed 1:10 ratio and Para 23(a) of the Instructions to Applicants dated 07.11.2016.
3. The candidates whose Register numbers are found in the above list have been provisionally admitted to the Main Written Examination based on the particulars furnished by them in their online applications such as age, educational qualification, Bar Council enrollment, Community, PSTM status, Differently Abled, Experience etc., subject to, verification and acceptance of their claim in the their online applications. Individual memorandum indicating the list of documents to be sent to the Commission is available in the Commission's Website. If any of their claims are found to be false or incorrect, their candidature is liable for rejection at any point of time.
 4. The candidates who have appeared for the Preliminary Examination and whose register numbers are not found in the above list have not been admitted to the Main Written Examination. Separate communication in this regard will not be sent to those candidates.
 5. The admission of the above candidates to the Main Written Examination is purely provisional subject to the final orders to be passed by the Hon'ble High Court of Judicature at Madras in the WP No. 29134, 29672 of 2019 and 1616 of 2020 and other cases/WPs if any, relating to this recruitment pending on the files of the Hon'ble High Court, Madras/Madurai Bench of Madras High Court.
 6. Candidates who have been admitted provisionally to the Main Written Examination are hereby advised to upload the scanned copy of all the relevant documents without fail. Failure to upload even any one of the essential documents will result in their non-admission to the next stage of selection.
