Post Code	Name of Post	Essential Qualification.
787	Junior Officer (Supervisory Trainee- P&A) at S-O level (on contract basis)	Graduate with Full time One year diploma in HR/Personnel Management from recognized university with 55% marks. Knowledge of computer basics i.e. MS Word, Excel, E-mail etc.
788	Junior Officer (Supervisory Trainee- F&A) at S-O level (on contract basis)	Full Time graduate in Commerce (B.Com) from recognized university with 55% marks. Knowledge of computer basics i.e. MS Word, Excel, E-mail etc.
Note# 1 The requirement of minimum % of marks shall be 50% for SC/ST/Internal candidates (HPPCL only)		
Note#2 In case, if the existing employees of HPPCL then employees who have acquired above qualification full time or part time or through correspondence/distance education shall be eligible/considered.		
Note#3 Relaxations of 5 years in upper age limit shall be given to the candidates belonging to Project Affected Families/Districts as approved by BOD of HPPCL.		
Note#4 Relaxation of 2 years in age and 2% in qualification be given in respect of all those candidates who have successfully completed apprenticeship Training in HPPCL.

In addition to above the terms and conditions of Government of Himachal Pradesh, Department of Personnel issued vide Notification No. Per (AP.B)B(15)-5/2014 dated 17-04-2017 regarding 15 marks, the evaluation parameters No.iii and xi for the post of Junior Officer (Supervisory Trainee- P&A) at S-O level (on contract basis) under Post Code: 787 and Junior Officer (Supervisory Trainee- F&A) at S-O level (on contract basis) under Post Code: 788 may be read as under:-

iii) Land less family/family having land less than 1 Hectare to be certified by the concerned Revenue Authority. However, this parameter shall be exclusively applicable only to members of Project Affected Family under HPPCL projects, over and above Other Himachalis/Non Himachalis, and as per definition of landless family in R&R Plan of HPPCL.


xi) Experience upto a maximum of 5 years in Govt./semi-Govt. Organization relating to the post applied for (0.5 mark only for each completed year)

OR

2.5 yrs. Of working experience on ERP SAP Platform OR Hydro Power Sector in Govt./CPSU/State PSU relating to the post applied for (0.5 mark only for each semester of each completed 6 month's tenure).
