It is hereby notified that in compliance with the Hon'ble High Court Orders of PIL 219 Of 2015 on the basis of the CBRT Examination held on 23/02/2020 to the post of Food Safety Officer In The Director, Institute Of Preventive Medicine Public (Health) Laboratories & Food (Health) Administration Department & Greater Hyderabad Municipal Corporation, the candidates with the following Register Numbers have been provisionally admitted in the ratio 1:3 for the verification of Certificates.

2. The candidates who are shortlisted for verification of Certificates are required to upload the Original Certificates, relating to Age, Qualifications, Community (Integrated), latest Creamy Layer exemption certificate in case of B.Cs as per Memo No. 3009/BCW/OP/2009, Government of Telangana, Backward Classes Welfare (OP) Department, Dt:18/12/2015 (prescribed format hosted on website), Certificates relating to claim of age relaxation, Study (from 4<sup>th</sup> class to 10<sup>th</sup> class) and if any, failing of upload certificates if any which they will may **not** be admitted in subsequent process of selection. In terms of the notification the candidates should possesses the requisite qualifications as on 31/12/2020.

3. In view of safety measures to prevent spread of Covid-19, Commission decided to conduct certificate verification in online mode. Travel to TSPSC can be avoided through online certificate verification. The certificates upload link and other details will be made available on the Commissions website shortly

4. If, on further verification it is found that any candidate is not eligible with reference to the particulars furnished by him/her in the Application Form / Check List / Certificates, the results of such candidate / candidates shall be cancelled at any stage of selection process.

5. The candidates must note that, those who applied under equivalence of qualification are admitted subject to verification of qualifications and other eligibility criteria to the satisfaction of the commission. Hence admission to the Verification of certificates is strictly "Provisional".
