1. In pursuance to the Notification dated:18.07.2019 cited at reference-1, recruitment process to fill up 40 posts of Armed Reserve Sub-Inspector (CAR/DAR) (Men) (Non-Hyderabad-Karnataka) including In-Service was initiated. After completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, Provisional Select List was published cited at reference-2.
2. Ten candidates who were selected for both the post of Sub-Inspector of Police (Civil) & Armed Reserve Sub-Inspector (CAR/DAR) namely Sri. Ahmad Tayyab Choudhari, Sri.Babuddin, Sri.Mohd Muzzamil, Sri.Bhutesh T. Sri.Chandrashekara Itagi, Sri.Chandrashekar A.M. Sri. Gururaj Chintakal, Sri.Shrishail, Sri.Uddappa Ashok Dhareppanavar, & Sri.Umesh Honnamore.have expressed their unwillingness to join the post of RSI (CAR/DAR) as per their affidavits cited at reference-3. Accordingly, considering the request of the above Ten candidates their candidature was cancelled vide order No.85/Rect-2/2019-20, dated:23.06.2020.
3. Due to the cancellation of candidature of Ten candidates, ten posts in Armed Reserve Sub-Inspector have remained unfilled. In order to fill up the ten posts this Provisional Select List is being published with the following conditions.

- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- b) The fact that the name of the candidate figures in this list does not give him any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
