PROVISIONAL SELECT LIST

1. In pursuance to the Notification dated:06.06.2019 cited at reference-1, recruitment process to fill up 04 posts of Armed Reserve Sub-Inspector (CAR/DAR) (Men) (Hyderabad-Karnataka) was initiated. After completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, Provisional Select List was published cited at reference-2.

2. One candidate who was selected for both the post of Sub-Inspector of Police (Civil) & Armed Reserve Sub-Inspector (CAR/DAR) (HK) namely, Sri.Babuddin, has expressed his unwillingness to join the post of RSI (CAR/DAR) (HK). As per his affidavit cited at reference-3. Accordingly, considering the request of the above candidate, his candidature was cancelled vide order No.85/Rect-2/2019-20, dated:23.06.2020.

3. Due to the cancellation of candidature of one candidate, one post in Armed Reserve Sub-Inspector as remained unfilled. In order to fill up the one post this Provisional Select List is being published with the following conditions.
