- 1. In pursuance to the Notification dated:06.06.2019 cited at reference-1, recruitment process to fill up 07 posts of Spl. Reserve Sub-Inspector (IRB) (Men) (Hyderabad-Karnataka) including In-Service was initiated. After completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment Rule, 2009, Provisional Select List was published cited at reference-2.
- 2. One candidates who was selected for both the posts of Sub-Inspector of Police (Civil) / and Spl. Reserve Sub-Inspector (IRB) namely Sri. Sri. Ravinaik Lambani, has expressed his unwillingness to join the post of Spl.RSI (IRB) as per his affidavit cited at reference-3. Accordingly, considering the request of the candidate his candidature was cancelled vide order No.86/Rect-2/2019-20, dated:23.06.2020.
- 3. Due to the cancellation of candidature of one candidate, one post in Spl. Reserve Sub-Inspector as remained unfilled. In order to fill up the one post this Provisional Select List is being published with the following conditions.

- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- b) The fact that the name of the candidate figures in this list does not give him any legal right for appointment to the post which will be dependent on the aforesaid conditions.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal/ Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
