ORDER::

In the reference 2nd read above Special DSC-2019(IEDSS) notification was issued on 15.02.2019 based on G.O.Ms.No.24 SE Dept Dated.15.02.2019.

In the references 3rd and 4th read above, the General Secretary, Andhra Pradesh Association of Special Educators and the Convener, IEDSS Sadhana Samithi, Andhra Pradesh made representations requesting to consider the previous TET weightage for the candidates, those who appeared TET examination previously and qualified.

In the reference 6th read above Govt. has directed go ahead with the process of filling up the vacancies of School Assistants(Special Education) under IEDSS as per the Special DSC-2019 notification as per the rules/Guidelines issued from time to time.

In this context it is informed that as per the clarification letter given by Rehabilitation council of India letter vide Rc.No.7-91/RCI-2011 dated 29.2.2012 with regard to passing of teacher eligibility test for appointment of special education teacher, it is clearly clarified that TET for special education teachers should be independent of TET for General Education.

Further, Government issued special DSC only in the year 2018, whereas when looked into the previous TET exams those are conducted for General Education and no separate TET exam was conducted for special education teachers in such case the merit of previous TET cannot be taken in to consideration. Moreover as per Rule.18 of Special DSC notification - For School Assistant (Special Education) selection will be on the basis of marks secured in the Written Test (TET-CUM-TRT) and Weightage only. Under Note it is clearly specified "Merit list will be generated on the basis of Written Marks (TET-CUM-TRT) + Weightage Marks. Total marks will be arrived by limiting to 100 (Hundred) only".

Hence, considering previous TET marks for preparation of merit list for this selection does not arise as the same is against the clarifications given by RCI and as well as against the norms mentioned in Special DSC 2019 notification.

In view of the above factual position, in the light of the Govt. memo in the reference 6th read above and as per the rules issued in G.O 1st read above, the representations received in the reference 3rd and 4th read above, for considering of previous TET marks for preparation of merit list for this selection is not feasible as per rules in vogue.
