**Remuneration for Retired Government Medical Officers of Central / State Government:**

Monthly remuneration will be paid as per Railway Board's letter no- 2008/E(GR)II/1/1 dated – 16.07.2012 and 2008/E(GR)II/1/5 dated -20.05.2014 by reducing his / her /pension from Last Pay Drawn (i.e. Basic Pay+DA) (Pay plus pension should not be more than the last pay drawn)

**Age Limit:** Candidates should not have completed more than 53 years of age as on - 01.07.2020. However, age relaxation will be given as per extent rules.

**Age limit for Retired Railway Doctors:**

Candidates should not have completed more than 65 years of age as on- 01 .07.2020.



**Terms & Conditions:**

Engagement of doctors would be on contract basis initially for a period up to 31.12.2020 as per administrative requirement on the basis of assessment of performance of CMPs or upto attaining 65 years of age whichever is earlier. However, services of these doctors can be terminated even before the expiry of the said period after giving **2 days** notice on either side. Railway administration reserves the right to terminate the contract at any time during the contract by giving 2 days prior notice or payment of 2 days remuneration without assigning any reason whatsoever. The services rendered as contract doctor is a stop gap arrangement and will not be taken in to consideration in case of their selection through UPSC. It will also not confer upon them any right for regularization or permanent absorption in the Railways. Other terms and conditions is mentioned in **Annexure - I & II**

**Terms and conditions for entering into contract with  
Medical Practitioners on full time basis**

1. The contract shall be entered into for Three month or less from the date of entering into the contract. The railway administration shall reserve the right to enter into fresh contract with practitioner for another term.
2. The full time Contract Medical Practitioner (herein after referred to as CMP) who enters into contract with the railways will not have any claim or right for his/her continuity in service or automatic extension of the term of contract.
3. During the validity of the contract, the CMP will be at liberty to terminate the contract for betterment of his/her career or on any other grounds by giving 02 days notice to the railways. The contract can also be terminated by the railways at any time during the contract by giving 02 days notice without assigning any reasons whatsoever Contract shall also be terminated if the CMP is found to be mentally or physically incapacitated.
4. The full time engagement will be purely on contract basis for a period not up to 31.12.2020 for specific area only or till regular selected ADMO becomes available or any further order regarding this.
5. The CMP shall undergo a medical examination, before the contract is entered into for his/her fitness to perform the work awarded to him/her.
6. At the time of entering into contract, the CMP shall produce certificates of him/her character and antecedents from two gazette officers of the central/state government.
7. At the time of entering into contract, the CMP shall produce original certificates for proof of his/her date of birth and educational qualifications.
8. Authorized absents without detriment to the terms shall be allowed at the rate of two days per month to be availed any time during the contract to the extent earned by the CMP till such time. Provided these facility shall be available to the CMP subject to fulfillment of conditions stipulated in clause 14 & 15 of the terms and conditions. Any CMP leaving his place of work on leave of absence/national holidays should get prior permission of the controlling authority.
9. The monthly fee for CMPs engaged for full time and the daily proportionate reduction from the fee in the event the CMP absents himself for periods exceeding those stipulate in the contract. are at the following rates:-

10. Full time CMPs may be provided unfurnished accommodation subject to availability. In case railway accommodation is provided to the CMP, an amount equivalent to the sum of HRA and license fee of the accommodation so provided shall be deducted from the monthly fee admissibly to the CMP.
11. The CMP may avail free medical treatment for self only except operations categorized as "special" in Para 622(8) of Indian Railway Medical Manual 2000 and treatment normally available at super specialty centre from his/her respective zonal railways hospitals during the currency of contract
12. The CMP shall be governed in respect of matters not referred to in these terms and conditions by any orders/amendments to the terms contract issued by the railways from time to time.
13. The CMP shall attend all normal tasks which any medical practitioner is conventionally doing. He/she will also attend emergencies and accidents.

14. The CMP shall issue sick/fitness certificates for a period up to 7 days, beyond which the certificate is issued by him/her should countersigned by regular Railway medical officer available at the nearest hospital/dispensary health unit.
15. The CMP should not perform administration work like pre-employment or periodical medical examination, sanction of leave to group "C" & "D" staff and certificate with respect to food items considered unfit for human consumption etc. However the CMP shall be allowed to permit group "C" & "D" staff casual leave if sought for 3 days or less at a stretch.
16. The CMP shall not make medical recommendation of any referred to Para 559 to 564 of Indian Railway Medical Manual (IRMM). 2000.
17. The CMP will not have any financial powers. However he/she may operate the imprest account in accordance with the guidelines contained in the IRMM. However the cash vouchers in such cases shall got countersigned by an authorized railway medical officer. No cash imprest account shall be recouped unless the proposal is countersigned by an Indian railway medical service officer.
18. The CMP shall not initiate/ review/accept the annual confidential reports of group "C" railway employees, however he/she shall, on request prepare and present the performance report of the staff.
19. The CMP shall not indent or condemn/ recommend for condemnation of any tools and plants.
