- 2. The marks (normalized) obtained by 2284 candidates who have duly appeared in written examination held on 27.11.2019 have been uploaded on Board's website. Candidates can view their marks by logging into their account in OARS module on www.dsssbonline.nic.in. Further, vide Notice no. 1083 dated 16.03.2020, the e-dossiers were called w.e.f. 18.03.2020 to 01.04.2020.
- **3.** The result has been processed keeping in view of the eligibility conditions and relaxation thereof in respect of educational qualifications etc. as on cut off date i.e. 21.08.2017 for post code-04/17.
- 4. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates including caste certificate as per Government of India instructions issued in this regard vide MHA OM No. 2/29/54-RPS, 19/11/54.
- **19.** The User department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt issued from time to time.
- **20.** Mere inclusion of the name of the candidate in the result notice does not confer any right upon the candidate over the post unless the user department is satisfied after such inquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the post.
- 21. The recruitment process for the post of Statistical Assistant under Post Code 04/17 in Planning Department, GNCT of Delhi is hereby closed subject to disposal of pending cases.
- 22. The Select panel/Waiting List in respect of UR/SC/ST/PH-OH Category for the post of Statistical Assistant under Post Code 04/17 in Planning Department, GNCT of Delhi has been maintained and the same shall be valid upto27.08.2021. Further, the Select panel/Waiting List could not be maintained in respect of OBC/PH-HH/VH/PH-AUTISM-MD category as no suitable candidate is available in respective category.
