In view of the schedule of ensuing JEE (Main) 2020 Examination from 01.09.2020 to 06.09.2020 and NEET (UG) Exam, 2020 to be conducted by the National Testing Agency (NTA) and in pursuance of Order No.4996/R&DM (DM) dated.28.08.2020 of Special Relief Commissioner & Addl. Chief Secretary to Government, Disaster Management Department, this Office Order No.13336/Emg./dated.27.08.2020 Pronouncing shut down of Jharsuguda Town from 30.08.2020 to 05.09.2020 and all other measures of restrictions/regulations which may follow stand revised so as to accommodate the relaxations declared by Government for facilitating the conveyance of Examinees, Guardians and Personnels on duty both to and from the Examination centre and smooth conduct of the said Examination as per the desired norms.


Group conveyance is being arranged from ITI, Jharsuguda as per following schedule.

- (1) First Bus service will start from 30.08.2020 at 09.00 AM to the destination Nodal ITI of Examination centre carrying the Examinees/Guardians whose Exam is scheduled on 01.09.2020, 02.09.2020 and 03.09.2020.
- (2) Second Bus service will start from 03.09.2020 at 09.00 AM to the destination Nodal ITI of Examination centre carrying the Examinees/Guardians whose Exam is scheduled on 04.09.2020, 05.09.2020 and 06.09.2020.

The Second Bus shall also ferry back the candidates who have appeared Exam on dated.01.09.2020, 02.09.2020and 03.09.2020. This Bus shall leave on 04.09.2020 at 09.00 AM from the Nodal ITI of the Examination location.

- (3) The last Bus service would be available on 07.09.2020 to bring back the Examinees/Guardians who have appeared the Exam on 04.09.2020, 05.09.2020 and 06.09.2020.
