List of Original Documents to be uploaded for digital verification

- 1 H.S.C. or equivalent certificate in support of declaration of age issued by the concerned Board/Council;
- 2 Post Graduate Degree Certificate in the concerned discipline in respect of educational qualification prescribed for the recruitment;
- 3 NET qualifying certificate;
- 4 Ph.D. Degree certificate;
5. Mark-list following examinations issued by the concerned Board/Council/University;
 - (i) **+2 or equivalent Marks**
 - (ii) **Bachelor Degree Marks**
 - (iii) **Post Graduate Degree Marks**
- 6 Candidates who have not been awarded percentage of marks, but only "GRADE" should along with their applications produce the conversion certificate from the concerned University indicating the actual equivalent percentage of marks and the conversion formula failing which, their applications are liable to be rejected;
- 7 Caste Certificates of **S.C./ S.T./SEBC** categories issued by the competent authority. SEBC category candidates must submit copy of caste certificate issued from competent authority **within the last three years** from the closing date of submission of online application form.

Women candidates belong to S.C./S.T./SEBC category are required to submit Caste Certificate by birth showing "daughter of" Caste Certificate by virtue of marriage (i.e. showing "Wife of" will not be accepted.
8. Discharge certificate issued by the **Commanding Officer** of the Unit last served wherever applicable.
9. Identity card issued by the **Director of Sports, Odisha** in case of Sports Persons wherever applicable;
- 10 Permanent Disability Certificate indicating percentage of disability of 40% or more) issued by the concerned **Medical Board**, wherever applicable;
- 11 OPSC challan copy (Pay in slip) for payment of fee at SBI;
- 12 If a candidate claim to possess qualification equivalent to the prescribed qualification, copy of Equivalence Certificate issued by competent authority to be submitted;
