## Notice for Physical Standard Test, Walking Test, Document Verification and Biometric Verification for the post of Forest Ranger, Department of Forests & Wildlife, Govt. of NCT of Delhi.

- The candidates who are provisionally shortlisted on basis of the Computer Based Test (CBT) for the post of Forest Ranger in the Department of Forests & Wildlife, Govt. of NCT of Delhi, as declared vide result notice no. F.No 1(39)/DCF(HQ)/Estt./Rect.-EdCIL/2019/2735-43 dated 04.09.2020 are now required to appear for Physical Standard Test, Walking Test, Document Verification & Biometric verification.
- 2. The Physical Standard Test, Walking Test, Document Verification and Biometric verification for the post of Forest Ranger is scheduled to be held on 12 October, 2020 at National Zoological Park (Delhi Zoo), Mathura Road, New Delhi-110003 at 04:30 AM sharp. The Physical Standard Test, Walking Test and Biometric verification, will be followed by verification of documents on the same day at the same venue.
- 3. No candidate without Admit Card (issued by the Department) and Photo identity card (Voter ID Card/ Aadhar Card/ Govt. ID/ Driving license) shall be allowed to enter the test venue.
- 4. Any kind of malpractices such as impersonation, canvassing, usage of steroids etc. shall invite penal action including rejection from present test as well as debarring from future examinations/tests.
- 5. The candidature to the Physical Standard Test, Walking Test, and Document Verification and Biometric Verification test is provisional and subject to the outcome of direction/decision/order, pronouncement of any Court of Law and mere issue of Admit Card or appearance at the Test does not entitle the candidate to any claim for the post.
- 6. The Department reserves the right to cancel a part of or entire process of test due to administrative reasons and/or in case of unfair means, cheating or other irregularities/malpractices if noticed by the Department.
- 7. The Department reserves the right to reject the candidature of any ineligible candidate at any stage of recruitment/selection.
- 8. Request for postponement of the Physical Standard Test, Walking Test, Document Verification and Biometric verification will not be entertained under any circumstances.
- 9. Any dispute with regard to this recruitment will be subject to courts/tribunals having jurisdiction over Delhi.

- 10. No TA/DA is admissible to any candidate for appearing in the test.
- 11. All the candidates are strictly advised to wear vest/T-Shirt for affixing chest badge for clear identification during Physical Standard Test and Walking Test.
- 12. The candidate should scrupulously follow these instructions and also that of the designated officers of the Department at the Test Centre failing which the candidature of the candidate shall be cancelled.
- 13. Candidates are advised to visit the website of the Department regularly for further information and detailed instructions.
- 14. The details of Physical Standard Test and walking Test requirements are presented below:
- (a) The minimum standards for height and chest girth for a candidate shall be as follows:

However, the above height standards are relaxable to the extent given below in case of candidates belonging to Scheduled Tribes and Races such as Assamese, Bhutanese, Garhwali's, Gorkhas, Kumaonise, Ladakhese, Mizo, Naga, Nepalese, Sikkimese and those from Arunachal Pradesh, Lahaul and Spiti, Meghalaya

- (b) Male/Female candidates must pass a Physical Test Covering a distance of 25/16 KMs respectively within four hours on foot.
- 15. It shall be mandatory for the provisionally shortlisted candidates to appear at the time of document and identity verification with the following original documents along with one self-attested Photostat copies of the same and two attested passport size photographs on 12<sup>th</sup> October, 2020 after the Physical Standard Test and Walking Test for the purpose of verification of his/her original documents:-
- (i) System generated printout of application with candidate's scanned photograph and signature.
- (ii) Proof of application fee receipt.
- (iii) Certificate/Marks-sheet of Secondary School Exam in which date of birth of the candidate is indicated.
- (iv) Degrees & Certificates of all educational and professional / higher qualification, along with marks-sheet of all years/semesters, if any.

- (v) Certificate/proof of SC/ST/OBC/Ex-servicemen/EWS etc., as the case may be, issued by the concerned Competent Authority. (If applicable)
- (vi) Candidates already employed with Govt. Departments/PSU/Autonomous Bodies will have to produce 'No Objection Certificate (NOC)' from the employer at the time of Joining Service, if offered appointment.
- (vii) Aadhaar Card, if not issued then registration slip for Aadhaar.
- (viii) Identity proof such as Voter ID Card, Passport, Driving License etc.
- (ix) All other documents, as per details given in the advertisement and/or call letter.
- 16. In case, a candidate does not appear for verification of documents/identity along with original documents, he/she shall not be eligible for appointment and his/her candidature shall be rejected. No second opportunity shall be provided for verification of documents/identity in any case.
