A complete list of candidates shortlisted for Pre-Employment Medical Examination for the post of ASSISTANT ENGINEER (ELECTRICAL) has already been notified in WBSEDCL Website (Career Section) vide Memo No: ES &ER-I/ ESTB/905 dated 13.07.2020.

The Pre-Employment Medical Examination for all shortlisted candidates is now being scheduled in phases owing to the current pandemic situation & state lockdown on various dates.

In the 2ND phase, 96 nos. candidates as per the enclosed list are hereby scheduled to appear for the Pre –Employment Medical Examination as per dates mentioned at **Calcutta Medical Research Institute (CMRI), 7/2, Diamond Harbour Road, Kol-700027.**

Following points are to be noted by the candidates in relation to the Pre-Employment Medical Examination:

1. The dates as mentioned against each in the enclosed list have been scheduled keeping in mind the announced dates of State wide Lock Down in West Bengal.
2. In case Lock Down is newly implemented on any of the scheduled dates mentioned in the enclosed list, the Pre-Employment Medical Examination for that date only would be cancelled. New revised date against the cancelled date would be communicated to the candidates in due course. All other dates would remain unchanged.
3. Keeping in mind the occasional lockdown resulting in probable disruption of surface transport, it is not very unlikely that few candidates may fail to attend the Medical Examination on the specified dates as scheduled. **As such, for candidates only who are resident of a state outside West Bengal, an option is being provided to arrange for medical examination to be done within 07 days of their respective scheduled date at his/her nearest State or Govt Hospital not below the level of District Hospital of his/her area of residence as per format which would be sent to the candidates individually via email along with other instructions.**


4. For all candidates in the enclosed list a letter detailing the instructions to be followed for attending the Pre-Employment Medical Examination at **Calcutta Medical Research Institute (CMRI)** or for getting the examination done at their nearest State/District hospital, as the case may be, would be sent individually via email in the next 2-3 working days.
5. Departmental candidates need not appear at Medical Test or submit Affidavit.
6. **All candidates are requested to submit the following documents to WBSEDCL representative present at Calcutta Medical Research Institute (CMRI) or send through courier/speed post positively. Candidates who will avail the option of getting the medical examination done at their nearest State/Govt. Hospital should also submit the following documents in original via Speed Post/Registered Post/Reputed Courier only:**
 - i. An affidavit in non-judicial stamp paper of denomination Rs.10/- or above as per the format enclosed
 - ii. Any other document/ affidavit which would be mentioned in the individual letter to be issued to them via email shortly

In case any candidate fails to attend the medical examination on any of the scheduled dates, the incumbent is advised to email a request letter at eseri.wbsedcl@gmail.com, stating valid reasons, for rescheduling of the medical examination which will be duly considered and accordingly intimated to him/her as per discretion of the competent authority.

Please note that candidates of outside the state of West Bengal who will avail the option of getting the medical examination done at their nearest State or Govt. Hospital (detailed under Clause No.3) as per format should positively send us all the medical investigation reports/X ray/ECG report etc. ^(ORIGINAL) duly signed and stamped by concerned doctor with registration no. through Speed Post/Registered Post/Reputed Courier positively. Please also note that no scanned document/photocopy of document of any nature would be accepted under any circumstances.
