SUPPLEMENTARY RESULT NOTICE NO: 668 DATED 23.09.2020

TGT (ENGLISH) MALE, POST CODE-131/17 IN DIRECTORATE OF EDUCATION.

The DSSSB vide its advertisement No. 04/2017 dated 22/12/2017 had advertised total **367** [UR-180, OBC-93, SC-49, ST-45, including PH (OH-05, VH-06)] vacancies for the post of **TGT (English) Male, Post Code-131/17 in Directorate of Education** with closing date as 31.01.2018. Tier-I examination in offline written examination mode was conducted on **02/09/2018**.

2. On the basis of offline examination of Tier-1 held on **02/09/2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (English) Male, Post Code-131/17** in Directorate of Education, a total of **246 (UR-168, OBC-11, SC-45, ST-22 including 04 PH)** candidates were provisionally nominated for the post of **TGT (English) Male, Post Code-131/17** vide Result Notice No. **429** dated **30.04.2019** and the candidature of **25 candidates** was kept pending for want of deficient documents / clarification and their documents were recalled w.e.f. **03.05.2019 to 12.05.2019** and **07 candidates** under OBC category were kept pending for verification of their OBC (Delhi) status. Further, a total of **15 candidates** (UR-03, UR/PH/VH-01, OBC-09, SC-01, ST-01) were provisionally nominated vide **Supplementary Result notice No. 562** dated **11/12/2019** and **12 candidates** were again kept pending for want of deficient documents in the e-dossier and 2nd & final opportunity was given to them w.e.f. **13.12.2019 to 22.12.2019**. Further, **10 candidates (UR-03, OBC-04, SC-03 including 01 PH)** were provisionally nominated vide **Supplementary Result Notice No. 580** dated **15.01.2020** and the candidature of 07 candidates (02 for want of deficient documents & 05 for court case candidates) was kept pending. The candidature of 02 candidates was revived vide supplementary Result Notice No. 562 dated 11.12.2019 and given an opportunity w.e.f. 13.12.2019 to 22.12.2019 but their e-dossier link could not be opened due to technical reasons. These candidates were given a fresh opportunity w.e.f. 04.06.2020 to 13.06.2020 vide notice dated 02.06.2020 to upload the deficient documents in the e-dossier.

3. Now, the User Department vide letter dated 26/12/2019 has returned the dossiers of 18 candidates (UR-12, OBC-00, SC-04, ST-02 including 01 PH/OH) after cancellation of their candidature for not appeared for documents verification in the User Department. Accordingly, 18 vacancies under (UR-12, SC-04, ST-02) have become unfilled. Therefore, the candidates from waiting panel are considered for nomination below the last selected candidate in their respective categories.

4. (i) Accordingly, in continuation to Result Notice No. **429** dated **30.04.2019**, Supplementary Result Notice No. **562** dated **11/12/2019** & Supplementary Result Notice No. 580 dated 15.01.2020, the candidates, as detailed below, are also provisionally selected on the basis of offline examination of Tier-1 held on **02/09/2018** and having been found provisionally eligible as per documents uploaded in support of educational qualification, age etc in accordance with advertisement No.04/2017 and RRs for the post of **TGT (English) Male, Post Code-131/17** in Directorate of Education.



5. * The candidate bearing roll No. 2650006545 under SC category was nominated earlier vide Result Notice No. 429 dated 30.04.2019 under SC category as per his merit. Now, after return of dossiers and merit became lower in UR category, his candidature is being shifted under UR category as per own merit candidate. Accordingly, the result notice no. 429 dated 30.04.2019 is modified and the user department is requested to update their record.

6. The selection of the above 16 candidates shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of advertisement inviting applications and subject to thorough verification of their identity with reference to their photographs, signatures/handwriting etc. on the application form, admission certificate etc. The candidature of the above candidates are liable to be cancelled by the User Department also, in case the candidates are found not to be fulfilling the terms & conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

7. The user department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department shall verify the genuineness of the Caste Certificates furnished by the candidates prior to issuing offer of appointment to the candidates. The Competent Authority of the user department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny /correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User





Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.

8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the Competent Authority prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.

9. The User Department shall also get the SC/ST/OBC/PH/ExSM/etc. certificates verified from the Issuing authority. Further, if applicable, User Department shall also verify the genuineness of the caste certificates furnished by the candidates prior to issuing offer of appointment to the candidates. In case of the OBC candidates, it may also be verified that the candidate does not belong to creamy layer of the schedule of Govt. of India, DoPT O.M. No. 36012/22/93-Estt. (SCT) dated 08.09.1993, O.M. No. 36033/3/2004-Estt. (Res) dated 09.03.2004 and 14.10.2009 and O.M. No. 36033/1/2013-Estt. (Res) dated 27.05.2013 & 13.09.2017.

10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his eligibility as laid down in the recruitment rules and after verification of the correctness of the information/documents as furnished in the application form and e-dossier vis-à-vis the original documents related to Educational Qualification, Age and other essential Certificates as per instructions issued by Govt. of India in this regard vide MHA O.M. No. 2/29/54-RPS, 19-11-54.

11. **The user department shall ensure that the appointment made is in conformity with DoPT guidelines and instructions of Govt. issued from time to time.**

11. Further, the candidature of following 03 candidates are being an opportunity to upload the deficient documents in the e-dossier as given below:-

12. The candidate bearing roll No. 2650002894 is being given five days 2nd and final opportunity to upload the deficient /requisite documents in the e-dossier **w.e.f. 25.09.2020 to 29.09.2020**, failing which his candidature will be rejected and no further opportunity will be given on whatsoever ground. **The e-dossier link shall be activated for the candidate bearing Roll No. 2650002894 w.e.f. 25.09.2020 to 29.09.2020 (Five Days only)**

13. Further, the candidates bearing roll No. 2650005781, 2650006022 are being given 10 days 1st opportunity to upload the deficient /requisite documents in the e-dossier **w.e.f. 30.09.2020 to 09.10.2020**, failing which their candidature will be cancelled and no further opportunity will be given on whatsoever ground.

14. The e-dossier link shall be activated for the candidates at para-13, w.e.f. 30.09.2020 to 09.10.2020.

15. The result process for the above post code stands closed in all respect except 03 pending candidates as referred above and 05 court case candidates.

16. Waiting panel which was valid for a period of one year from the date of declaration of result i.e. upto 29.04.2020 as per earlier **result notice no. 429 dated 30.04.2019** has been expired on 29.04.2020.

17. Mere inclusion of name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.


18. The category wise marks obtained by the last selected candidates have been given as under:-

Note:- In advertisement no. 04/17, in para-2 (vii) - Mode of Selection (Examination Scheme), it has been mentioned that "If there are two or more candidates in the same category having equal marks in the examination, the candidate older in age will get preference. In case of further tie, candidate having higher marks in Section "A" of the test shall be preferred".
