- Note-1. As regards 'Appeal' against the medical status indicated in the above list,
  - a. Candidates at Serial No.10,11&13 have already been given opportunity for medical appeal and the period for appeal is over.
  - b. Candidates at Serial No. 01,02 & 07 are eligible for final medical appeal and they should apply till <u>06.00</u> <u>PM of 05 October 2020 by Speed Post only</u>. After appeal, no further chance will be given for Medical Examination
  - c. Candidates at Serial No. 01& 02 should appeal against the decision of Divisional Medical Committee to Principal Chief Medical Director (PCMD), WCR through the Chairman, Railway Recruitment Board, Bhopal 462010.
  - d. Candidate at Serial No. 07 should appeal against the decision of Divisional Medical Committee to Principal Chief Medical Director (PCMD), WR through the Chairman, Railway Recruitment Board, Bhopal 462010.
  - 2. 'Appeal' from a candidate will be entertained, only if
    - a. Application for medical appeal is in the formal attached.
    - b. The candidate produces a medical certificate (as per enclosed Proforma 'A') from a Government/Private doctor of the specialty/specialties in which the candidate has been found unfit.
    - c. The medical certificate should contain a note that the Government/Private specialist is fully aware of the physical & visual standards set by the Railways for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three senior railway doctors appointed by the Government in this regard
    - d. The Government/Private Doctor should attest the photo of candidate and also clearly mention his MCI/State registration number.
    - e. **Medical Appeal Application by candidate** should be accompanied by a Demand Draft of Rs.1000/-payable in favour of FA&CAO, West Central Railway, Jabalpur. Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The recommendations of Medical Board duly approved by PCMD will be communicated to the candidate through RRB/Bhopal. In case, the decision changes from Unfit to Fit, the DD submitted will be returned to the candidate. In all other cases, this DD will be credited to Railway Revenue.
