Appeal against the decision of Divisional Medical Board/Committee against CEN 02/2018 for the post of Level-1.

After Document & Candidature Verification for the post of Level-1 (As per 7th CPC) under CEN 02/2018 conducted in different dates at RRC/ECR/Patna, candidates were sent for Medical Examination to Divisional Railway Hospital/Danapur, DDU, Dhanbad, Sonpur and Samastipur. In Medical Examination, some candidates have been found unfit in all medical categories (i.e. A-2 to C-2) and some have been found fit in B-2 to C-2 but unfit in A-2 to B-1. Besides that, due to non availability of vacancies in medical category B-2 & C-1 and not advertised in C-2 medical category post, **such candidates would not be considered for empanelment. These candidates were given a chance to appear before Divisional Medical Board (DMB). The decision of the DMB will be final and binding on the candidates. Further, Candidates who failed to appear before DMB on scheduled date will be decided for provisionally empanelment as per fitness in their initial medical report.**

However, if candidates who appear before DMB and want to appeal against the decision of DMB may submit the same to Principal Chief Medical Director, East Central Railway, Hajipur through the Chairman, Railway Recruitment Cell, East Central Railway Patna till 06.00PM of 4th December 2020.

After appeal, no further chance will be given for Medical examination.

Such and appeal shall be entertained, only if:

- (i) The candidate produces a certificate from a Government/Private Doctor of the speciality /specialities in which the candidate has been found unfit.
- (ii) Such certificate should contain a note that the Government/Private specialist is fully aware of the physical & visual standards set by the Railway for the particular medical category, and that he is aware of the fact that the candidate has already been declared unfit according to these standards during medical examination conducted by an appropriate Medical Board comprising of three Senior Railway Doctors appointed by the Government in this regard (Certificate should be as per enclosed Proforma "A")
- (iii) The certificates should bear the photograph and mark of identification of the candidates duly attested by such a Government/Private Doctor, the issuing authority.
- (iv) Such an issuing authority shall also clearly mention its MCI/State Registration Number.
- (v) Charges will however be payable by candidate and towards this end, a candidate will be required to pay Rs.1000/- through **DD payable in favour of PFA/East Central Railway/Hajipur.**

Where PCMD is of the opinion that there should be re-examination of the case of appeal, he may nominate a Medical Board to re-examine the candidate. The recommendations of Medical Board duly approved by PCMD will be communicated to the candidate through RRC/ECR/Patna.

In case, the decision changes from Unfit to Fit in A-2 to B-1 or upgraded in A-2 to B-1 from B-2 to C-2, the DD submitted will be returned to the candidate. In all other cases, this DD will be credited to Railway Revenue.
