**Supplementary Result Notice for the post of Wildlife Guard/Game  
Watcher**

1. The Department of Forests and Wildlife, Govt. of NCT of Delhi vide result Notice no. F.No 1(39)/DCF(HQ)/Estt./Rect.-EdCIL/2019/2744-52 dated 04.09.2020 has provisionally selected 11 candidates respectively for the post of Wildlife Guard/Game Watcher on the basis on online examination held on 15<sup>th</sup> March, 2020 and document verification/Biometric Verification was held on 09<sup>th</sup> Oct, 2020.
2. During the Document Verification/Biometric Verification on 9<sup>th</sup> October, out of 11 candidates, 10 candidates appeared for Document Verification /Biometric Verification. The candidate having roll number 141200300736 category unreserved Ex-serviceman did not appear for Document Verification/Biometric Verification.
3. According to the notice published in departmental website for document verification dated 10/09/2020, which clearly mentioned, *"No second opportunity shall be provided for verification of documents/identity in any case"*. Keeping in view this notice, the details of the next candidate (Waiting list) in the merit list of ex-serviceman category for document verification/biometric verification is as follow: -

4. It shall be mandatory for the provisionally selected candidate to appear at the time of document and identity verification with the following original documents along with one self-attested Photostat

copies of the same and two attested passport size photographs on **5 November, 2020** for the purpose of verification of his/her original documents:-

(i) System generated printout of application with candidate's scanned photograph and signature.

(ii) Proof of application fee receipt.

(iii) Certificate/Marks-sheet of Secondary School Exam in which date of birth of the candidate is indicated.

(iv) Degrees & Certificates of all educational and professional / higher qualification, along with marks-sheet of all years/semesters, if any.

(v) Certificate/proof of SC/ST/OBC/Ex-servicemen/EWS etc., as the case may be, issued by the concerned Competent Authority. (If applicable)

(vi) Candidates already employed with Govt. Departments/PSU/Autonomous Bodies will have to produce 'No Objection Certificate (NOC)' from the employer at the time of Joining Service, if offered appointment.

(vii) Aadhaar Card, if not issued then registration slip for Aadhaar.

(viii) Identity proof such as Voter ID Card, Passport, Driving License etc.

(ix) All other documents, as per details given in the advertisement and/or call letter.

5. In case, a candidate does not appear for verification of documents/identity along with original documents, he shall not be eligible for appointment and his candidature shall be rejected. No second opportunity shall be provided for verification of documents/identity in any case.


