### **Document Verification Notice for Non-PwBD Candidates Against CEN 02/2018**

**Dated 18-11-2020**

1. Based on performance in CBT conducted by RRBs against CEN 02/2018 and Physical Efficiency Test conducted by Railway Recruitment Cell/Guwahati (RRC/GHY) for Level-1 posts against CEN 02/2018, the Document Verification (DV) of 293 Non-PwBD candidates bearing Roll Numbers given below was scheduled to be held on 26-03-2020 and 27-03-2020 at Railway Higher Secondary School, Alipurduar Junction, Alipurduar, West Bengal, PIN-736123 against absentee/disqualified Non-PwBD candidates shortlisted for earlier DVs. However, due to onset of covid-19 pandemic the same was postponed.
2. **The Document Verification will now be held for these 293 candidates from 30-11-2020 to 05-12-2020 at NFRSA Ground, Maligaon, Near Rang Bhavan, Guwahati. Candidates to note the change of venue. The schedule for DV is attached herewith. Candidates are advised to report, without fail, to the venue of DV, as per the date & time mentioned against their Roll Numbers in the lists given below.**
3. Candidates who fail to attend the DV as per schedule due to valid reasons may attend the Absentee DV on 07-12-2020 at the same venue. Absentee DV will be held only on valid and acceptable grounds on production of supporting documents.
4. The Roll Numbers are arranged in a random order and not in order of merit.
5. After Document Verification process, candidates will be directed for medical examination for which they may have to stay for 5-6 days. The venue of Medical Examination is also indicated against the Roll Numbers. Candidates are advised to come prepared accordingly. Candidates may book tickets in advance to the venue of medical examination, so that they can leave immediately after DV.
6. Candidates will have to undergo Covid-19 testing at the venue of DV. Those found positive will have to undergo isolation/quarantine as per extant rules of Govt. of Assam. Candidates have to maintain Covid-19 protocols at all times during their travel and at the time of DV/Medical examination such as wearing of masks, social-distancing, use of hand-sanitisers etc. Candidates should strictly ensure that their stay at Guwahati is not more than 72 hours and they should plan their travel accordingly.
7. The candidature of all the shortlisted candidates for DV is purely provisional and is liable to be cancelled, at any stage of recruitment or thereafter, in case of any inconsistency/deficiency in the data furnished by them in their online application or any malpractice on the part of candidates coming to the notice of RRBs/RRCs at any stage of the recruitment process.
8. The number of candidates shortlisted for DV is 1.05 times the remaining Non-PwBD vacancies. The purpose of calling 5 % extra candidates for DV over and above the remaining vacancies is primarily to avoid shortfall in the panel. Merely calling a candidate for DV does not, in any way, entitle him /her to an appointment in the Railways.
9. **The call letters for DV will be made available on RRC/GHY website shortly.**
10. The candidates are advised to carefully go through the instructions contained in the call letters for their DV for information and compliance.

11. The candidates must bring the lower-half-portion (candidate's copy) of admit cards for Computer Based Test (CBT) and Physical Efficiency Test (PET) to be produced during DV without fail.
12. The candidates must also bring all the required certificates in original in the prescribed proforma as mentioned in para 17 of CEN 02/2018 dated 10-02-2018 (under heading "Verification of Original Documents and Format of Certificates") and para 9 of Corrigendum no. RRBs/CEN 02-2018/Corrigendum-1 dated 28-02-2018. Failure to produce the required documents during DV will lead to disqualification of the candidate and no additional time will be given to the candidates for production of required documents/testimonials.
13. It may be noted that merely calling a candidate for DV does not entitle him/her in any way to an appointment in the Railways. Their consideration for further process of recruitment is subject to them being found eligible in DV and Medical Examination by the Railways.
14. Although utmost care has been taken to publish the details correctly, RRC/GHY reserves the right to rectify any inadvertent errors or typographical/printing mistakes at any stage.
