

3. Candidates may note that only **01(One)** vacancy has been advertised for the post of Supervisor(OL) and final result shall be prepared provisionally after verification of all the documents submitted by the individual candidates.

The above said list is purely provisional and subject to the candidate fulfilling all the eligibility conditions prescribed for the post of Supervisor (OL) in the Advertisement No.01/2020 and also subject to thorough verification of their identity with reference to their photographs, signatures, handwritings, etc., on the application forms, admission certificates, etc. If, on verification, it is found that any candidate does not fulfil any of the eligibility conditions, he/she will not be considered for final result. The candidature of these candidates is **PROVISIONAL** subject to their being found eligible in all respects.

Due to the ongoing COVID-19 pandemic it was decided by the Competent Authority to verify the documents online and process the final result based on the suitability of the candidates after verification of the documents submitted by the candidates online. Detailed instructions shall be shared with the individual candidates through a separate call letter. Candidates have to forward all the requisite documents mentioned in the call letter positively by **04.12.2020** after which no claim shall be entertained from the candidates.
