PROVISIONAL SELECT LIST

1. In pursuance to the Notification dated: 18.07.2019 cited at reference, recruitment process to fill up 200 posts of Sub-Inspector of Police (Civil) (Men & Women) including In-Service was initiated. The Endurance Test and Physical Standard Test to all the candidates who had applied for selection to the above said posts was conducted and further written examination was conducted on 05.01.2020 to all the candidates who had qualified in the Endurance Test and Physical Standard Test.

2. Whereas, as per the procedures laid down in the Cadre and Recruitment (Amendment) Rules, 2009 & 2016, after completing the above said process, provisional select list in the order of merit of candidates equal to the number of vacancies notified should be published. Accordingly, the provisional select list is prepared and published vide cited at reference-2.


3. 07 candidates who were selected in both lists i.e., Sub-Inspector of Police (Civil)-200 & 300 posts. They have expressed their unwillingness to join the post of Police Sub-Inspector (Civil) in the list of 200 posts as per their affidavits cited at reference-3. Accordingly, considering the request of the above 07 candidates, their candidature was cancelled.

4. Due to the cancellation of the candidature of 07 candidates, 07 posts in Sub-Inspector of Police (Civil) have remained unfilled. In order to fill up the 07 posts this Provisional Select List is being published with the following conditions.

- a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
- b) The fact that the name of the candidates figures in this list does not give them any legal right for appointment to the post which will be dependent on the aforesaid condition.
- c) This select list is subject to the final decision of the Hon'ble Karnataka State Administrative Tribunal / Hon'ble High Court of Karnataka / Hon'ble Supreme Court of India.
