## CANDIDATURE CANCELLATION NOTICE No. 1090 Welfare Officer/Probation Officer/Prison Welfare Officer In Social Welfare Department, GNCTD Post Code 14/19

- 1. Attention is drawn to the Notice No. 880 dated 23/01/2020 vide which the marks of candidates were declared who appeared for the written Examination held on 24/11/2019 and to the Result Notice No. 968 dated 06/03/2020 vide which results were declared for the Post of Welfare Officer/Probation Officer/Prison Welfare Officer in Social Welfare Department, GNCTD under Post Code 14/19.
- 2. Attention is also drawn to the Board's Order No F.55 (155)/Exam/DSSSB/2019/Pt. File/1113-23 dated 16/07/2020 vide which the Candidate Vipin Kharub, having roll No. 4500003095 under post code 14/19, DOB:-22/07/1987, S/o Narendra Kumar, H. No. 59, Village Bhalaswa, Delhi has been debarred from any examination conducted/ to be conducted by DSSSB for life time w.e.f. 24/11/2019. Further, candidature of Sh. Vipin Kharub will be deemed cancelled if he appeared in any examination conducted by the Board prior to above date.
- 3. That vide above-mentioned debarment order dated 16/07/2020 it has been found/conveyed to all that Sh. Vipin Kharub whose details are mentioned in table below, was found indulging in unfair means, malpractices and criminal activities like Cheating, Impersonation, Forgery, Conspiracy, etc. during the above said post code exam:-

4. Further, it is not out of place to mention here that the Candidates appearing in various examinations being conducted by the DSSSB have repeatedly been warned not to resort to any unfair means/malpractices and further, that:

'Any attempt to commit or abet, as the case may be, all or any of the acts such as (i) Impersonating, and (ii) Procuring impersonation by any person, may in addition to rendering himself/herself liable to criminal prosecution, be liable:

a) To be disqualified by the Board from the examination for which he/she is a candidate as also from any other examination/selection of the Board in which he/she might have appeared but the final result/selection has not been declared/made and or

- b) To be debarred either permanently or for a specified period by the Board from any examination held or selection made by them and or,
- c) To take disciplinary action under appropriate rules if he/she is already in service under Government and or,
- d) To take any other legal action.'
- 5. Further, attention is drawn to the following provisions of the "General Instruction" for candidates for the various post codes in online, offline and PET examination.

"If any case of impersonation comes to notice then overall in-charge and observer shall lodge FIR against both persons, i.e., candidate who applied and the impersonator under relevant sections. These persons shall also be debarred from appearing in future exams of DSSSB and other Board/Commissions."

- 6. The candidates Sh. Jagdish Maurya and Sh. Vipin Kharub though appeared for themselves but impersonated as Sh. Jagdish Maurya by Sh. Vipin Kharub and Sh. Vipin Kharub by Sh. Jagdish Maurya by bubbling roll numbers of each other instead of themselves in the OMR Sheet. Sh. Jagdish Maurya blacken the bubbles (machine readable spots by which machine identifies the roll number of a candidate) under the digits of his roll number that of Sh. Vipin Kharub. Sh. Vipin Kharub also blacken the bubbles under the digits of the roll number that of Sh. Jagdish Maurya.
- 7. Therefore, it is evident that both candidates were actively involved in the crime related to impersonation on OMR answer sheet by bubbling roll numbers of each other instead of their own roll numbers, cheating, forgery, connivance, and conspiracy as specified in Indian Penal Code.
- 8. Vide debarment order dated 16/07/2020, the DSSSB had come to the conclusion that, prima facie, a case of impersonation, on OMR answer sheet, cheating, forgery, connivance and conspiracy was made out against the candidates.
- 9. Therefore, it is evident that the candidate along with impersonator was actively involved in the crime related to impersonation, cheating, forgery, connivance and conspiracy as specified in Indian Penal Code.
- 10. The DSSSB adheres to ZERO TOLERANCE POLICY TOWARDS ANY MISCONDUCT by any candidate or any persons. Therefore, in view of the above facts and circumstances and as mentioned in debarment order no. F.55 (155)/Exam/DSSSB/2019/Pt. File/1113-23 dated 16/07/2020, the candidature of the candidate Sh. VIPIN KHARUB, S/o NARENDRA KUMAR, R/o H. No. 59, Village Bhalaswa, Delhi having Date of Birth 22/07/1987 bearing roll no. 4500003095 of post code 14/19 is hereby cancelled and the provisional selection made vide Result Notice No. 968 dated 06/03/2020 of Sh. VIPIN KHARUB, S/o NARENDRA KUMAR, R/o H. No. 59, Village Bhalaswa, Delhi having Date of Birth 22/07/1987 bearing roll no. 4500003095 of post code 14/19 is hereby rescinded.
