In pursuance of Notice No. 15/2/2018-RHQ (Vol.II) dated 20.01.2020 and SSC (HQ)'s letter dated 04.11.2020, it has been decided that Document Verification process of candidates provisionally qualified at Scrutiny Stage for the post categories of SSC(ER) i.e. ER10119, ER10219, ER10319, ER10419, ER10519, ER10619, ER10719, ER10819, ER10919, ER11019, ER11119, ER11219, ER11319, ER11419, ER11519, ER11619, ER11719, ER11819, ER11919, ER12019, ER12119, ER12219, ER12319 advertised under Phase-VII/2019/Selection Posts will be held from 18.01.2021 till 01.02.2021 in the Office premises of SSC (ER), Kolkata.

- 2. However, in view of COVID-19 pandemic situation, the Commission has decided to allow the facility of change of Regions for Documents verification of candidates, provisionally qualified in Scrutiny Stage under Phase-VII/2019/Selection Posts.
- 3. Candidates who have appeared in Online Computer Based Mode of Examination from Eastern Region but willing to appear in Document Verification in Centre of other Regional/Sub-Regional Offices of the Commission should submit their willingness to this Regional Office by Speed post or through email at recttsscer.wb-dopt@gov.in by 17:00 Hrs of 31.12.2020.
- 4. Similarly, the candidates who have appeared in Online Computer Based Mode of Examination from Other Regional/Sub-Regional Offices, but would like to have done their document verifications in SSC (ER), Kolkata should also submit their willingness to this Office by 17:00 Hrs. of 31.12.2020.
- 5. Candidates should clearly mention their particulars viz. Name, Roll No., Registration No. and Post Category No. while sending their willingness to this Office.
- 6. If such request for change of centre of DV Process is not received from the candidates in this Office by 31.12.2020, document verification of such candidates will be held in the Office premises of SSC (ER), Kolkata. Any request in this regard received after 17:00 Hrs. of 31.12.2020 will not be entertained in any manner and the Commission shall not be responsible for any postal delays in this regard.
- 7. Detailed schedule of Document Verification will be uploaded on the website of SSC (ER) in the first week of January, 2021.
