3. MINIMUM EDUCATIONAL QUALIFICATIONS:

A. Graduate Apprentices:

- A Degree in Engineering or Technology granted by a Statutory University in relevant discipline.
- A Degree in Engineering or Technology granted by an Institution empowered to grant such degree by an Act of Parliament in relevant discipline.

B. Technician (Diploma) Apprentice:

- A Diploma in Engineering or technology granted by a State Council or Board of Technical Education established by a State Government in relevant discipline.
- A Diploma in Engineering or Technology granted by a University in relevant discipline.

4. AGE:

Age limit will be followed as per Apprenticeship Rules.

5. RESERVATION OF VACANCIES:

Guidelines under Apprentices act on Reservation for SC/ST will be followed. Candidates claiming reservation under SC/ST shall provide certificate as per Government standard format, failing which their claim for reservation will be considered as General category. Candidates belonging to SEBC/OBC category will also be considered as General category only.

6. MINIMUM PHYSICAL STANDARDS:

As prescribed in Clause 4 of the Apprenticeship Rule 1992 and amendments thereof any.

7. DURATION OF TRAINING:

The duration of Apprenticeship training will be for period of 01 (One) year as per Apprentices (Amendment) Act 1973.

8. PREVIOUS TRAINING/EXPERIENCE:

Candidates who have already undergone or are currently undergoing apprenticeship under Apprentices (Amendment) Act 1973, and/or having one year or more experience are not eligible to apply.

9. SELECTION PROCEDURE:

The final selection list would be prepared according to categories i.e. General / SC / ST after conducting certificate verification and personal interview by OPTCL.
