State Level Police Recruitment Board, Andhra Pradesh issued notification vide Rc. No. 04/R&T/Rect.1/2020, dt: 02-11-2020 for recruitment of 58 Nos. of Scientific Assistants (Physical, Chemical & Biology/Serology) in Forensic Science Laboratory, A.P.

2) The Written Test for the above post was held on 06-12-2020 at 24 centres, 5 locations from 11.00 AM to 01.00 PM. The candidates are advised to download their data and marks obtained by them in the Written Examination from the website www.slprb.ap.gov.in from 18-12-2020 at 11.00 AM onwards. - 6) This facility will be available from 18-12-2020 to 20-12-2020 till 05.00 PM and the candidates will be informed the result of “verification” through SMS and e-mail, registered with SLPRB. In case of any improvement in marks, the fee submitted by such candidate will be refunded by SLPRB, Andhra Pradesh.
- 7) Those candidates who apply for “verification” are informed that the OMR Sheet will be scanned once again and marks awarded will be checked as per the Final Answer Key already released.
- 8) Candidates are requested to download Scanned copy of OMR Sheets and verify the marks awarded. They must mention specific reason while requesting for “Verification” so that their grievance may be looked into.
- 9) Each valid representation received with fee will only be examined and the decision of the committee in the matter shall be final. No further communication or Anonymous/Incomplete representations will be entertained after the last date.
- 10) Candidates should also download the Applicant’s details and verify whether the information is correct or not. If the data needs any correction (except Post applied), such candidates should send their requests along with relevant documents through their registered Mail ID to apslprb.fslobj@gmail.com from 19-12-2020 to 21-12-2020. Requests sent to any other e-mail IDs cannot be considered. Similarly, the mails received after 21-12-2020 cannot be considered under any circumstances and they will be treated as “summarily rejected”.
