- 1. The DSSSB vide its advertisement no. 03/2019 with closing date 15/10/2019 had advertised 637 vacancies {UR-332, OBC-119, SC-115, ST-35, EWS-36 including 13 PH (OH) and 14 PH (VH)} for the Post of Assistant Teacher Primary under post code 15/19 in Directorate of Education, GNCTD.
- 2. The written examination (online mode in three shift) Tier-I for recruitment in respect of this post was conducted on 11th, 13th, 14th and 15th November, 2019.
- 3. Candidates have given two opportunities for uploading deficient documents between 31.07.2020 to 09.08.2020 (1st re-call) and 01.09.2020 to 05.09.2020 (2nd re-call) respectively. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 03/2019 and Recruitment Rules for the post of Assistant Teacher (Primary) under post code 15/19 in Directorate of Education, GNCTD. The candidature of these candidates, therefore, stands rejected:-

1	12321115454	UR	Candidate has claimed age relaxation under GCT category however as per documents submitted/uploaded by the candidate she has worked as guest faculty in school run by New Delhi Municipal Council which is not in accordance with circular dated 10.07.2019 issued by Services Department, GNCTD related to relaxation of upper age limit to the contractual employee.
2	11221101792	OBC(D)	Candidate has not submitted valid CTET certificate, inspite of giving two opportunities.
3	12321112282	SC	As per document submitted by candidate the date of declaration of CTET was 15.06.2012 and as per guidelines the validity of CTET score is upto 7 years from the declaration of result, hence, validity of CTET score was upto 14.06.2019. Since cut off date for this post code was 15.10.2019, hence candidate was not having valid CTET on cut off date for this post code.
4	11211103398	EWS	As per documents submitted by the candidate he has not requisite educational qualification on cut off date i.e. 15.10.2019.
5	112101102143	PH(VH)	As per document submitted by candidate result for final year of D.El.ED was declared on 25.01.2020 i.e. after cut off date, hence candidate has not requisite educational qualification on cut off date i.e. 15.10.2019.
