The DSSSB vide its advertisement no. 02/2018 with closing date 13/08/2018 and Addendum dated 26.08.2019 had advertised 1024 vacancies (UR-516, OBC-277, SC-154, ST-77 including EXSM-102 & PH(OH)OL-41) for the Post of Nursing Officer under post code 03/18 in Health & Family Welfare Department. The Board had conducted Tier-I (T) written examination on 27<sup>th</sup> 28<sup>th</sup>, 29<sup>th</sup> 30<sup>th</sup> August 2019 and 30<sup>th</sup> September 2019(online).
2. The candidature of candidates having Roll Nos. 11300901168, 12370903402, 12380900128 and 12370907626 were kept pending vide Result Notice No. 996 dated 13/06/2020 and Supplementary Result Notice No. 1058 dated 30/09/2020 respectively. The e-dossier link was activated between the period 25.06.2020 to 04.07.2020 and 06/10/2020 to 10/10/2020 respectively for uploading the deficient documents by the candidates.
3. On scrutiny of the documents uploaded by the candidates in the e-dossier module, the candidates bearing following Roll Nos. in respect of the above mentioned post code have been found to be 'Not Eligible' in terms of the advertisement no. 02/2018 and Recruitment Rules for the post of Nursing Officer under post code 03/18 in Health & Family Welfare Department, GNCTD. The candidature of these candidates, therefore, stands rejected:-

B.D.Sharma University of Health Science, Rohtak on 09/04/2019 (date of declaration of result), which is after cut off date, hence candidate has not possessed requisite educational qualification on the time of cut off date i.e. 13/08/2018.
2	12370903402	OBC(OS)/EX	As per documents submitted by the candidate, candidate has done Medical Assistant 2nd Class Qualifying Course (practical training for a 28 weeks), which is not covered under education qualification prescribed for the post of Nursing Officer.
3	12380900128	UR/EX	As per documents submitted by the candidate, candidate has Medical Assistant Certificate, which is not covered under education qualification prescribed for the post of Nursing Officer.
4	12370907626	ST/EX	As per documents submitted by the candidate, candidate has done Medical Assistant 2nd Class Qualifying Course (practical training for 28 weeks) and other related courses, which is not covered under education qualification prescribed for the post of Nursing Officer.
