After completing the recruitment process as per all the procedures laid down in the Cadre and Recruitment Rule, 2009, Provisional Select List was published cited at reference-2.
- 2. Eight candidates who were selected for more than one post i.e., Sub-Inspector of Police (Civil), Spl. Reserve Sub-Inspector (IRB) and Spl. Reserve Sub-Inspector (KSRP) namely Sri. Sunil B.C., Sri. Rahul Reddy, Sri. Vinod G., Sri. Adharshakumara G.R., Sri. Srishail Kenchannavar, Sri. Sanjay K.R., Sri. Basagouda Nerli & Sri Mohan K.K., have expressed their unwillingness to join the post of Spl.RSI (KSRP) as per their affidavits cited at reference-3. Accordingly, considering the request of the above Eight candidates, their candidature was cancelled vide order No.86/Rect-2/2019-20, dated:30.11.2020.
- 3. Due to the cancellation of candidature of Eight candidates, Eight posts in Spl. Reserve Sub-Inspector have remained unfilled. In order to fill up the Eight posts this Provisional Select List is being published with the following conditions.
 - a) This list is subject to the outcome of the results in the medical examination to be held by a Medical Board constituted as per the rules.
 - b) The fact that the name of the candidate figures in this list does not give him any legal right for appointment to the post which will be dependent on the aforesaid conditions.
