- The DSSSB vide its advertisement no. 03/2019 with closing date 15/10/2019 had advertised 637 vacancies {UR-332, OBC-119, SC-115, ST-35, EWS-36 including 13 PH (OH) and 14 PH (VH)} for the Post of Assistant Teacher Primary under post code 15/19 in Directorate of Education, GNCTD.
- 2. The written examination (online mode in three shift) Tier-I for recruitment in respect of this post was conducted on 11th, 13th, 14th and 15th November, 2019.
- 3. DSSSB vide Result Notice No. 1015 dated 24/07/2020 and No. 1033 dated 24/08/2020 has provisionally selected 616 & 10 candidates respectively for the post of Assistant Teacher Primary under **post code 15/19** in Directorate of Education, GNCTD.
- 4. Further candidature of 11 candidates having Roll No. 12321115454 in UR Category, Roll Nos. 11171101189, 11151101414 and 11221101792 in OBC Category, Roll No. 12321112282 in SC Category, Roll Nos. 11111100129, 11161100084, 11171100864, 11211103398 and 11171102631 in EWS Category and Roll No 11201102143 in PH(VH) Category were kept pending vide Result Notice No. 1015 dated 24/07/2020 & Supplementary Result Notice No. 1033 dated 24/08/2020. - 5. The candidature of 01 candidate having roll no. 11151101414, which was earlier kept pending in OBC Category vide Result Notice No. 1015 dated 24/07/2020 and Suppl. Result Notice No. 1033 dated 24/08/2020 is now hereby rejected in OBC Category as the candidate is not eligible to seek reservation benefit under OBC (Delhi) category. The candidate was given two opportunities by Board in between 31/07/2020 to 09/08/2020 (10 days in 1st re-call) and subsequently, in between 01/09/2020 to 05/09/2020 (05 days in 2nd and final re-call) vide above mentioned result notices, respectively, to upload deficient document i.e. OBC (Delhi) certificate issued by the Competent Authority. The above pending 01 candidate (EWS-01) is being given opportunity to upload their pending/all requisite/applicable documents through the e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be actived <a href="from 15/12/2020">from 15/12/2020</a> to 24/12/2020, failing which his/her candidature will be rejected and no further opportunity will be given on whatsoever ground. The above candidate is also

- being separately informed through SMS on their registered mobile number as additional facility.
- 9. The provisional selection of the above 10 candidates (UR-01, OBC-03, SC-01, EWS-04 & PH (VH)-01) shall be further subject to thorough verification of the candidature of the candidate by the User Department including ascertaining the identity of candidates.
- 10. The provisional selection of above 10 candidates (UR-01, OBC-03, SC-01, EWS-04 & PH (VH)-01) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied himself about their eligibility as laid down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Directorate of Education, GNCTD shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 12. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it

may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.

- 14. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 16. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 17. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 18. Further, the result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
