## SUPPLEMENTARY RESULT NOTICE NO. 1091 Welfare Officer/Probation Officer/Prison Welfare Officer In Social Welfare Department, GNCTD, Post Code 14/19

- 1. The DSSSB vide its advertisement no. 02/2019 with closing date 05/03/2019 had advertised 110 vacancies (UR-55, OBC-31, SC-16, ST-08 including PH(OH)-04, PH(VH)-01) for the Post of Welfare Officer/Probation Officer/Prison Welfare Officer under post code 14/19 in Social Welfare Department, GNCTD. The Board had conducted Tier-I (T) written examination on 24/11/2019 in offline mode.
- DSSSB vide Result Notice Nos. 968 dated 06/03/2020 had provisionally nominated 103 candidates, vide Supplementary Result Notice No. 1023 dated 04/08/2020 the Board had provisionally nominated 06 candidates (including, against one rescinded candidate in SC Category who was earlier selected vide Result Notice No. 968) and vide Supplementary Result Notice No. 1078 dated 04/11/2020 had provisionally nominated 2 candidates respectively for the post of Welfare Officer/Probation Officer/Prison Welfare Officer under post code 14/19 in Social Welfare Department, GNCTD. Therefore till date against advertised 110 vacancies, 110 candidates had already been provisionally nominated by DSSSB in post code 14/19.
- 3. Further, in view of debarment order no(s). Dated 16/07/2020, candidature of 02 candidates having roll no. 4500003092 and 4500003095 who were earlier provisionally nominated vide Result Notice No. 968 dated 06/03/2020 in UR category and OBC Category, respectively, have now been rescinded and their candidature(s) also get cancelled vide Candidature cancellation order no. 1089 and 1090 dated 18/12/2020. Due to rescindment and candidature cancellation of these 2 candidates (UR-1, OBC-1), 2 vacancies arose in Post Code 14/19 (UR-1, OBC-1).
- 4. Now, on the basis of written examination Tier I (T) held on 24/11/2019 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc., in accordance with the advertisement no. 02/2019 and RRs for the Post of Welfare Officer/Probation Officer/Prison Welfare Officer under post code 14/19 in Social Welfare Department, GNCTD, the following candidates are hereby provisionally nominated as per their merit:

- \*The candidate having roll no. 4500001757 having D.O.B. 28/11/1990 being older in age than other candidates having equal marks has been last selected candidate in OBC Category.
- \*\* As per direction of Ld. CAT in OA No. 1146/2020, the selection of last candidate in OBC Category shall be subject to outcome of the said OA.
- 5. The selection of the above **02 candidates (UR-01, OBC-01)** shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- The Selection of the above 02 candidates (UR-01, OBC-01) shall further be subject to 6. genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough reference their photographs, identity with to their verification signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.
- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Social Welfare Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- 8. It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 9. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it



may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/I/2013-Estt. (Res) dated 27/05/2013 & 13.05.2017.

- 10. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 11. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 12. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 13. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.
- 14. The result is subject to the outcome of OA No. 1146/2020 and other court cases, if any, pending in various courts related to this post code.
