Appointment to the post of (ESP category) of clerk against Advt. No. 5/2019 cat. NO.-1 Recommendation thereof of Director General Health Service, Haryana (Field Cadre).

On the recommendation of Haryana Staff Selection Commission Panchkula, send vide their letter No. HSSC/Confd./ Recomn/2020/653 dated 19.11.2020, and 5151 dated 30-12-2020 Director General Health Services, Haryana is pleased to offer you appointment as clerk on the station mentioned against your name in the pay Level of FPL-2 @ 19900/-P.M. plus usual allowances as may be admissible from time to time, on purely provisional basissubject to condition that in case if your certificate/documents found fake/bogus, your candidature will be cancelled automatically without any notice/intimations.

- 2. You will be entitled to draw such allowances and other benefits as sanctioned by the Government from time to time.
- 3 The post is temporary and your appointment will be terminable on one month notice on either side or one month salary including allowances in lieu of notice (except in case of removal/dismissal for misconduct). It will however be open to Govt. to pay in lieu of notice your salary for the period by which the notice falls short of one month and similarly if you wish to resign from the post, you may do so by depositing with Government your salary in lieu of notice for the period by which it falls short of one month. Such notice of resignation should be addressed to competent authority. The condition will, however not be applicable in case of your services are dispensed with during the probation period.
- 4. You will be on probation for a period of two years from the date of joining which can be extended of necessary up to three years. The services put in against the temporary post might be counted towards the period of probation but the completion of two years temporary services will not itself entitle you to confirmation unless the post is substantively vacant. You shall be covered under New Pension Rules as notified vide No. 1/1/2004-IPension, dated 18.08.2008.
- 6. On appointment/joining you will be required to take an oath of allegiance to the Constitution of India.
- 7. You will furnish the certificate to the effect that you have not more than one living spouse, not married to a person already having one living husband/wife and you were not on any previous occasion dismissed from service under any department of Government or convicted by a Court of law or no cases is pending against you in any court of law.
- 8. In case you are married, you will have to file a declaration about non acceptance/giving of dowry. If you are unmarried, you shall have to furnish a declaration immediately after marriage regarding non acceptance/giving of dowry by you to the office as per declaration in Annexure A and B in terms of Government instruction issued vide No.18//2/2017-2GS-I dated 22.12.2017
- 9. A declaration in writing that you were not on any previous occasion dismissed from service under any department of Government or convicted by a Court of Law or no case is pending against you in any court of law.
- 10. Your seniority will be determined according to your position in the merit list sent by Haryana Staff Selection Commission.
- 11. You are liable to be transferred anywhere within or outside the state of Haryana.

12. You are required to produce you academic certificate in original and furnish a Medical Certificate of fitness before joining from the Medical Board constituted under Rule9 of Haryana Civil Services (General) Rules, 2016. You should appear for medical examination in the office of Civil Surgeon concerned of your district.

In case you have already appeared before the Medical Board in Haryana during the past 6 month and declared medically fit, you need not to appear for the same. In case you are already employed somewhere under the Haryana Govt. and you have already produced a medical certificate to the department, you may be exempted from producing fresh medical certificate provided there no break in your service and you produce a certificate from your employer.

- 13. The appointment is provisional and is subject to the academic qualification certificate/Schedule Castes/Schedule Tribes/Backwards Classes/ESM/DFF etc. certificate and any other declaration being verified through proper channel and if the verification reveals that the claims to belong to academic qualification certificate/Schedule Castes/Schedule Tribes/Backwards Classes/ESM/DESM/DFF etc. as the case may be, is false, the services will be dispensed with forthwith without assigning any further notice and without prejudice to such further action as may be taken under the provisions of the Indian Penal Code for production of false certificate.
- 14. The offer of appointment is further subject to the verification of character and antecedents, in case it is found that appointee in not of good character and anything is adverse against him/her. His/her services will be dispensed with at once without any notice to him/her in this regard.
- 15. You will have to qualify the state Eligibility Test in Computer Appreciation and Application (SETC), within the probation period of two year extendable by one year, You shall not be entitled to earn any increment in your pay scale till you qualify the said test, failing which your services shall be dispensed with.
- 16. If you are willing to accept this offer of appointment on the above mentioned terms and conditions, you should report to the station mentioned against your name for joining within 15 days from the date of issue of this letter, no extension in joining time would be allowed. If you fail to report for duty within stipulated period, it will be presumed that you are not willing to accept this offer of appointment and your candidature will be treated as cancelled.
