**FINAL RESULT NOTICE FOR THE POST OF FOREST RANGER**


1. Department of Forests and Wildlife, Govt. of NCT of Delhi vide its Direct Recruitment Notice dated 27/12/2019 with closing date 16.02.2020 had advertised 04 vacancies (UR-03, OBC-01) for the post of **Forest Ranger** in the Department of Forests and Wildlife, Govt. of NCT of Delhi.
2. Department of Forests and Wildlife conducted computer-based test for recruitment in respect of this post on 16 March, 2020.
3. Based on the performance in computer based test, 16 (UR-12, OBC-04) candidates (in the ratio of 1:4), who obtained marks above or equal to cut off marks in their respective categories were shortlisted to appear in Physical Test and Physical Standard Test.
4. The Physical Standard Test, Walking Test, Document Verification and Biometric verification for the post of Forest Ranger was held on 12 October, 2020 at National Zoological Park (Delhi Zoo), Mathura Road, New Delhi-110003.
5. Based on the performance in Physical Standard Test, Walking Test on 12<sup>th</sup> October, 2020, out of 16 candidates, 15 candidates appeared for Physical Standard Test/Walking Test. The candidate having roll number 301450100308 did not appear for the Physical Standard Test/Walking Test. Out of 15 appeared candidates, 11 candidates qualified for the Physical Standard Test/Walking Test.
6. On the basis of Written Examination, Physical Standard Test/Walking Test, Document Verification and Biometric Verification the following candidates are hereby provisionally selected as per their merit, according to Roll Nos. of Written Examination of the candidates.

12. This issues with the prior approval of the Competent Authority.


