**Subject:** Filling up of the posts of Medical Officer (Allopathic) in H&FW Department- Verification of documents and release of recommendations thereof.

Order No. 2E-PSC of 2021 Dated: 6.01.2021

Whereas, Health & Medical Education Department vide communication No. HME/HRM/162/2018 Dated 10.06.2020 and 21.07.2020 referred Nine hundred (900) posts of Medical Officer (Allopathic) in H&FW, to the J&K Public Service Commission, for being filled in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and allowances) and fixation of Tenure Rules, 2020, as per the following breakup;



Whereas, J&K Public Service Commission, accordingly, notified these 900 posts, vide Notification No.01-PSC(DR-P) of 2020 dated:30.07.2020, inter-alia mentioning that the no. of vacancies may undergo minor changes after receiving clarification from Health Department, category wise breakup of the posts as also the factum regarding horizontal reservation, for inviting applications and for admission of eligible candidates to the Written Test, for selection in accordance with SRO 388 dated:10.09.2018 which reads as under:

".... the posts of Medical Officer shall be filled on the basis of written test only to be conducted by the J&K Public Service Commission.";

and

Whereas, in reference to commission letter no. PSC/Exam/MO(Allo) 2018 Dated 13.02.2019, the indenting Department had intimated that 50 unfilled vacancies are backlog



vacancies of various categories and that the same should also be filled up alongwith these 900(new) vacancies. However the actual backlog vacancies are 29 (RBA:15, SC:01, ST:03 & ALC:10) therefore the number of vacancies is 929; and

Whereas, in the above said notification it has been specified that the candidate/s who are domiciled in the Union Territory of J&K and possessing the prescribed academic and professional qualification and age for the said post alone are eligible for applying. Besides, the last date of receipt of online applications provided in the notification (i.e. 04.09.2020) shall be the cutoff date for determining the eligibility as regards education & professional qualification; and

Whereas, written examination was held on 01.11.2020 and 2122 candidates appeared in the said examination; and

Whereas, the result of written test was declared on 10.11.2020 and the eligible shortlisted candidates were directed to get their documents verified at J&K Public Service Commission offices at Jammu & Srinagar w.e.f. 17.11.2020 to 28.11.2020; and

Whereas, Commission recommended 459 candidates in the select list and 168 candidates in the wait list for appointment as Medical Officer on 14.12.2020 vide letter no.PSC/Exam-WT/MO/2020/06 in whose case the documents were complete in all respect; and

Whereas, recommendation w.r.t. 183 candidates from the select list & 64 candidates from the wait list were kept withheld due to deficiency of various documents; and

Whereas, a number of representations were received from the candidates representing that the issuing authorities had not issued the documents in time i.e. before cutoff date 04.09.2020 due to prevailing pandemic and other reasons; and

Whereas, in pursuance of Commissions decision no. 11.3 dated:08.12.2020, a Committee of the Members of the Commission was constituted vide order no.169 –PSC of 2020 dated:18.12.2020 to look into the cases wherein the recommendations have been kept withheld on account of candidates having submitted documents viz. Domicile/Registration certificates etc. issued/obtained after the cutoff date and that the Committee shall scrutinize these cases and make appropriate recommendations for consideration of the Commission; and



Whereas, a notice dated:18.12.2020 was also issued and the candidates were conveyed that if he/she wishes to make any representation before said Committee of Members, the same may be done within five days positively; and

Whereas, a number of candidates have submitted representations to the Commission/Committee and requested the Commission to accept their documents such as Domicile/Registration & Category Certificates which have been issued after the cutoff date. They have requested that even though they had applied for these documents well in time, the delay in issuance of documents has been caused solely due to the disruptions arising out of Covid 19 pandemic; and

Whereas, the Committee after detailed examination and deliberations has furnished its report on 30.12.2020 with recommendations as under:

" The Committee examined the documents produced by the Commission Secretariat including the representation submitted by the candidates (list and representations on file). It was observed that delay in submission of the documents has mainly been because of the Pandemic. The Committee also observed that number of relaxation/condonation have been granted by various Competent authorities/ departments of the Government, with regard to submission of Income Tax Returns, GST Returns, exemption of Medical Examination for APRs in respect of employees, extension of validity of motor vehicle documents by Ministry of Road Transport & Highways and in many other similar situated matters for the reason of pandemic. Having regard to aforementioned facts the Committee is of the opinion that a similar view needs to be taken in respect of the candidates who have submitted their documents in the Commission by or before 29.12.2020. Needless to mention that it remains undisputed matter of fact that there is only delay in submission of documents as pointed out by the candidates, whose, recommendations were earlier withheld. Issuance of the deficient documents by the concerned competent authorities suggests that all these candidates are possessing the requisite qualifications and for these reasons those have been issued in their favour.

Be it noted that such relaxation should be granted as one time exemption because of Covid-19 and not treated as a matter of course in future."

Now therefore, the above recommendations of the Committee are hereby adopted by the Commission and the candidature with respect to

candidates annexed as Annexure-A is hereby released as one time exception and the recommendations of these candidates be made to the Government in continuation to the letter dated:14.12.2020 for their appointment.
