- 1. The DSSSB vide its advertisement number 01/2017 with closing date 21/08/2017 and subsequent Addendum dated 01/09/2019 and corrigendum to addendum dated 15/11/2019 had advertised 842 vacancies (UR-400, OBC-170, SC-106, ST-166 including OH-09, HH-48, VH-23, EXSM-129 AND SP-24) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17. Board Conducted Tier-I written examination for recruitment in respect of this post on 20/09/2019, 24/09/2019, 30/09/2019, 01/10/2019, 03/10/2019 and 04/10/2019. Board had declared marks of Tier I written examination of the Candidates of the Post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17 vide notice number 867 dated 19/12/2019.
- 2. Based on the performance in the One Tier Examination, 5404 candidates were shortlisted for appearing in Skill Test/Typing Test for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17 vide notice number 867 dated 19/12/2019. The Skill Test/Typewriting Test was conducted on 24/12/2019, 26/12/2019, 27/12/209, 28/12/2019, 29/12/2019, 30/12/2019, 03/01/2020, 04/01/2020 and on 16/02/2020 wherein out of 4437 candidates only 1893 candidates could qualify. The result of skill test was declared vide notice no. 1043 dated 08/09/2020.
- 3. As per RRs for the Post the candidate was to qualify the 35 w.p.m. in typewriting in English or 30 w.p.m. in typewriting in Hindi.
- 4. On the basis of written Examination Tier-I held from 20/09/2019, 24/09/2019, 30/09/2019, 01/10/2019, 03/10/2019 and 04/10/2019 and being qualified in Skill Test held on 24/12/2019, 26/12/2019, 27/12/209, 28/12/2019, 29/12/2019, 30/12/2019, 03/01/2020, 04/01/2020 and on 16/02/2020 and having been found provisionally eligible as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 01/2017 and RRs for the Post of Lower Division Clerk under Post Code 02/17 in Services Department, DSSSB vide Result Notice No. 1072 dated 12/10/2020 has provisionally selected 658 candidates (UR-275, OBC-115, SC-77, ST-132, EXSM-23, Sports-10, OH-07, HH-01, VH-18) for the post of GRADE-IV (DASS)/JR. ASSISTANT in Services Department, Govt. of NCT of Delhi under Post Code 02/17.

Further, candidature of 22 candidates (UR-01, OBC-04, SC-02, ST-03, EXSM-03, Sports-07, OH-02) were kept pending vide Result Notice No. 1072 dated 12/10/2020 and e-dossier link for uploading deficient documents was activated between 16/10/2020 to 25/10/2020 (1st re-call). Now, in view of additional documents furnished by these candidates whose candidature was kept pending for required documents, after preliminary scrutiny of the candidature of the candidate as per the provisions of the Statutory Recruitment Rules and Terms & Conditions of the Advertisement, the following candidates are hereby provisionally nominated as per their merit:-

In accordance with addendum dated 01/09/2019 of DSSSB, there were 32 backlog vacancies in HH Category and 18 vacancies in VH Category, wherein, it was clearly mentioned that "candidates are also informed that if suitable candidates shall not be available to fill 18 backlog vacancies reserved for VH category and 32 backlog vacancies reserved for HH category, then these vacancies may be filled by suitable candidates of another PwD category." and in reference to section 34 sub section 2 of The Right of persons with disabilities Act, 2016. 31 backlog vacancies in HH category is hereby inter se exchanged to OH category. Further, there are only 16 eligible candidates available in the waitlist panel in PH(OH) category, as per documents uploaded in support of Educational Qualification, Age, etc. in accordance with the advertisement no. 01/2017 and RRs for the Post of Lower Division Clerk under Post Code 02/17 in

The above pending 10 candidates (OBC-02, SC-01, ST-02, Sports-03 & PH(OH)-02) are being given 2nd and Final Opportunity to upload their pending/requisite/applicable documents through e-dossier link on OARS module of the Board within stipulated time. The e-dossier link shall be active from 13.01.2021 to 17.01.2021, failing which there candidature will be rejected and no further opportunity will be given on whatsoever ground. The above candidates are also being separately informed through SMS on their registered mobile no. as an additional facility.
- 9. The selection of the above 28 candidates (UR-01, OBC-02, SC-01, ST-01, EXSM-03, Sports-04, OH-16) shall be further subject to thorough verification of the candidature of the candidate by the User Department including the identity of the candidate.
- 10. The Selection of the above 28 candidates (UR-01, OBC-02, SC-01, ST-01, EXSM-03, Sports-04, OH-16) shall further be subject to genuineness of the documents on the basis of which they have claimed to have fulfilled all the eligibility conditions as prescribed in the RRs and terms and conditions of the advertisement inviting application and subject to thorough verification of their identity with reference to their photographs, signature/handwriting, etc. on the application form, admission certificate, etc. The Candidature of the above candidates are liable to be cancelled by the user department also, in case the candidates are found not to be fulfilling the terms and conditions of the advertisement inviting applications for the said post code. The Competent Authority of the Department concerned shall issue the appointment letter to the candidates after being satisfied about their eligibility as down in the recruitment rules and after verification of the correctness of the information furnished in the application form and the documents related to Educational Qualification, Age and other essential certificates.

- The User Department shall also check the eligibility of the reservation benefit, if any. Further, if applicable, the User Department i.e. Services Department shall verify the genuineness of the caste certificate furnished by the candidate prior to issuing offer of appointment to the candidates. The Competent Authority of the User Department shall arrange to verify the correctness of the information/documents as furnished in the e-dossier vis-à-vis the original documents. User Department is requested to ascertain the scrutiny/correctness of the same at their own level before issuing the offer of appointment to the provisionally selected candidates. Further, the appointing authority shall verify and satisfy itself about the authenticity of documents/certificates and essential qualification for the post before finally appointing the candidate. The User Department is also requested to rectify/correct, in case, any minor/clerical error/deficiency noticed in the documents of the candidate at their own level.
- It is stated that the User Department shall verify the genuineness of the caste certificate furnished by the candidate in the light of Notification No. 36012/22-93-Estt. (SCT) dated 08/09/1993 issued by DOPT and other instructions/guidelines issued from time to time by the competent authorities prior to issuance of offer of appointment to the candidate. It is further stated that, prior to appointment, the User Department must satisfy, itself, that the above candidates are fulfilling the necessary criteria as prescribed for entitlement of OBC (Delhi) certificate as specified in various Orders/Guidelines/Circulars including order dated 07/03/2017 issued by Revenue Department, GNCTD after thorough verification of caste certificate.
- 13. The User Department shall also get the SC/ST/OBC certificates verified from the issuing authority before his /her appointment. Further, in case of OBC Candidates, it may also be verified that the candidate does not belongs to creamy layer of the schedule of Govt. of India, DOPT O. M. No. 36012/22/93-Estt. (SCT) dated 08/09/1993 O. M. No. 36033/3/2004-Estt. (Res) dated 09/03/2004 and OM No. 36033/3/2004-Estt. (Res) dated 14/10/2008 and OM No. 36033/1/2013-Estt. (Res) dated 27/05/2013 and 13/05/2017.
- 14. The Competent Authority of the Department concerned shall issue the appointment letters to the candidates after being satisfied about his/her eligibility as laid down in the Recruitment Rules and after verification of the correctness of the information furnished in the application form and the documents related to education qualification, age and other essential certificates as per Government of India instructions issued in this regards vide MHA OM No. 2/29/54-RPS, 19/11/54.
- 15. The User Department shall ensure that the appointment made is in conformity with DOPT guidelines and instructions of Govt. issued from time to time.
- 16. Mere inclusion of the name of candidate in the result notice does not confer any right upon the candidate over the post unless the appointing authority is satisfied after such enquiry as may be considered necessary that the candidate is suitable in all respect for appointment to the Post.
- 17. While every care has been taken in preparing the result, the DSSSB reserves the right to rectify errors and omissions, if any detected at any stage.

- 18. The result is subject to the outcome of the court cases, if any, pending in various courts related to this post.
