The Online Examination for the posts of Forest Guard and Forest Guard with Driving Licence were conducted on 08.03.2020 and 16.03.2020. The Questions and Answers that were challenged were considered and the final answer keys were published on 09.11.2020.

The Certificate Verification, Physical Standards Verification were conducted at Chennai from 05.01.2021 to 07.01.2021 and on 18.01.2021. The Endurance test was conducted at Chennai on19.01.2021. The list of registration numbers of candidates provisionally selected for appointment by Direct Recruitment to the posts of Forest Guard and Forest Guard with Driving Licence was published on 24.01.2021.
