





Guidelines for Medical Examination

1. He/She should bring with him/her the photocopy of the Call letter issued for Interview containing his/her photograph for verification of his/her Identity with any valid identity card (Voter I.D. card/Pan Card/Aadhar Card/Passport etc. having his/her photograph).
2. He/She should report for Medical check-up there in EMPTY STOMACH for necessary Tests/Examinations.
3. He/She will be offered a complimentary breakfast by the Medical Centre at the time of Medical examination.
4. No Travelling Allowance/Travelling Expenses will be paid.
5. The report of Medical Test shall be forwarded directly to WBSEDCL by the hospital authority.
6. Necessary cost for such examination will be borne by WBSEDCL.
