Subject: Filling up of the posts of Medical Officer (Allopathic) in H&FW Department- Verification of documents &Cancellation of the candidature thereof.

Order No.//-E-PSC of 2021 Dated: 69 -02.2021

1. Whereas, Health & Medical Education Department vide communication No. HME/HRM/162/2018 Dated 10.06.2020 and 21.07.2020 referred nine hundred (900) posts of Medical Officer (Allopathic) in H&FW, to the J&K Public Service Commission, for being filled in terms of the Jammu and Kashmir Probationer (Condition of Service, Pay and Allowances) and fixation of Tenure Rules, 2020, as per the following breakup;

- 2. Whereas, J&K Public Service Commission, accordingly, notified these 900 posts, vide Notification No.01-PSC(DR-P) of 2020 dated 30.07.2020, inter-alia mentioning that the no. of vacancies may undergo minor changes after receiving clarification from Health Department, category wise breakup of the posts as also the factum regarding horizontal reservation, for inviting applications and for admission of eligible candidates to the Written Test, for selection in accordance with SRO 388 dated:10.09.2018 which reads as under:
- " the posts of Medical Officer shall be filled on the basis of written test only to be conducted by the J&K Public Service Commission.";

3. Whereas, with reference to Commission's letter no. PSC/Exam/MO(Allo) 2018 Dated 13.02.2019, the Indenting Department had intimated that 50 unfilled vacancies are "backlog vacancies" of

various categories and that the same should also be filled up alongwith these 900(new) vacancies. However the actual backlog vacancies were 29 (RBA:15, SC:01, ST:03 & ALC:10) therefore, the number of vacancies to be filled up were determined as 929;

- 4. Whereas, in the above said notification it has been specified that the candidate/s who are domiciled in the Union Territory of J&K and possessing the prescribed academic and professional qualification and age for the said post alone are eligible for applying. Besides, the last date of receipt of online applications provided in the notification (i.e. 04.09.2020) shall be the cutoff date for determining the eligibility as regards education & professional qualification;
- 5. Whereas, written examination was held on 01.11.2020 and 2122 candidates appeared in the said examination;
- 6. Whereas, the result of written test was declared on 10.11.2020 and the eligible shortlisted candidates were directed to get their documents verified at J&K Public Service Commission offices at Jammu & Srinagar w.e.f. 17.11.2020 to 28.11.2020;
- 7. Whereas, Commission recommended 459 candidates in the select list and 168 candidates in the wait list for appointment as Medical Officer on 14.12.2020 vide letter no.PSC/Exam-WT/MO/2020/06 in whose case the documents were complete in all respect;
- 8. Whereas, recommendation w.r.t. 183 candidates from the select list & 64 candidates from the wait list were kept withheld due to deficiency of various documents;
- 9. Whereas a number of representations were received from various candidates stating therein that due to Covid-19 Pandemic, the Govt offices were operating at 50% of the staff and they were as such not able to get their Domicile Certificate / Category Certificate/ Registration Certificates etc before the stipulated date even though they had applied well in time;
- 10. Whereas a committee comprising of 2 Hon'ble Members was constituted by the Commission to scrutinize these representation on case to case basis;
- 11. Whereas, the Committee of Hon'ble Members after detailed examination and deliberation has furnished its report on 30.12.2020 with recommendation as under;-



"The Committee examined the documents produced by the Commission Secretariat including the representation submitted by the candidates (list and representations on file). It was observed that delay in submission of the documents has mainly been because of the Pandemic. The Committee also observed that number of the relaxation / condonation have been granted by various competent authorities / departments of the Government, with regard to submission of Income Tax Returns, GST Returns, exemption of Medical Examination for APR's in respect of employees, extension of validity of motor vehicle documents by Ministry of Roads Transport & Highways and in many other similar situated matters for the reason of Pandemic. Having regards to aforementioned facts the Committee is of the opinion that similar view needs to be taken in respect of the candidates who have submitted their documents in the Commission by or before 29.12.2020. Needless to mention that it remains undisputed matter of the fact that there is only delay in submission of documents pointed out the candidates. as by recommendations were earlier withheld. Issuance of the deficient documents by the concerned competent authorities suggests that all these candidates are possessing the requisite qualifications and for these reasons those have been issued in their favour.

Be it noted that such relaxation should be granted as one time exemption because of Covid-19 and not treated as matter of in future."

- 12. Whereas, on the recommendation of the Committee, the Commission decided to accept the deficient documents which have been issued/ submitted by or before 29.12.2020;
- 13. Whereas, as a consequence of this recommendations in favour of 151 candidates from the selection list and 48 candidates figuring in the wait list were released vide letter No. PSC/Exam-WT/2020 dated 06.01.2021;

14. Whereas, a number of representations were further received from the remaining withheld candidates, pleading therein for release of their recommendation as they have already submitted the deficient documents through various modes well in time (ie; 29-12-2020);

- 15. Whereas, upon further scrutiny of the documents of all the remaining candidates, it has been found that the documents in respect of only 12 candidates figuring in the selection list and in respect of 05 candidates figuring in the waiting list were complete in all respects and accordingly the recommendation in respect of these candidates was released vide Letter No.PSC/Exam-WT/MO/2020 dated;-03.02.2021;
- 16. Whereas, the 77 candidates as per details given below did not turn up/chose not to present themselves for verification of their documents on the stipulated dates or even there after:-
