SOP for conducting Examination : In the context of COVID-19

(In addition to the SOP prevailing at the relevant time)

- i. The generic preventive measures include simple public health measures that are to be followed to reduce the risk of COVID-19. These measures need to be observed by all the concerned at the Examination Venue at all times. Any activity/event that can lead to overcrowding may strictly be prohibited.
- ii. Entrance to have mandatory hand hygiene (sanitizer dispenser) and thermal screening provisions. Multiple gates/separate gates, if feasible, should be used for entry and exit.
- iii. All Candidates reporting for the Examination will be subjected to thermal temperature screening. If the temperature of the Candidate is beyond the prescribed temperature limits, he/she will not be permitted to enter the Examination premises.
- iv. Posters / standees on preventive measures about COVID-19 to be displayed prominently.
- v. Proper crowd management in the parking lots, in corridors and in elevators – duly following physical distancing norms shall be organized.
- vi. Entry of visitors shall be strictly restricted. NO parents/relatives, etc. shall be allowed to enter in the Examination Venue.
- vii. Use of face covers/masks to be made mandatory. Further, Candidates are required to be in possession of individual hand sanitizer bottle and a spare N95 mask.
- viii. Respiratory etiquettes to be strictly followed. This involves strict practice of covering one's mouth and nose while coughing / sneezing with a tissue / handkerchief / flexed elbow and disposing off used tissues properly, self-monitoring of health by all. Spitting shall be strictly prohibited.
- ix. The staff of the High Court is strictly following the COVID-19 Protocol, nonetheless, the Candidates shall have to render the "No Risk Certificate" given at Appendix 'A' and same has to be deposited at the time of reporting for the Examination.
