## INSTRUCTIONS FOR APPEARING IN THE PERSONAL INTERVIEW

Please note that the above candidates would be required to produce the following documents for verification at the time of interview:

1. (i) Copy of Online Application Form (ii) Copy of Score Card (iii) Original testimonials related with educational qualification, experience certificate (indicating the period and nature of experience), date of birth, caste/category/Income & asset certificate (OBC/EWS certificate should not be issued earlier than 01 year from the date of issue of this letter), disability certificate in support of the claim for relaxation, discharge certificate in case of Ex. Servicemen (if applicable) PAN Card & Aadhaar Card and other related documents (one set of photocopy with self-attestation) (iv) Applicants who are awarded gradation under the CGPA system are required to bring proof issued by University / Institutes converting the CGPA gradation into appropriate percentage, which should meet advertised requirement for the post (v) 05 latest passport size coloured photograph (vi) If applicable, you have to bring "No Objection Certificate" along-with Vigilance Clearance Certificate issued by the present employer (Govt./Semi-Govt./Autonomous body/society/PSU/PSB) in case you have not submitted application through proper channel. (vii) If applicable, the reservation to EWS category of candidates is issued subject to judgement / outcome of petition pending before the Constitutional Bench of Hon'ble Supreme Court of India.
2. One set of photo-copies of all the certificates and testimonials duly attested/self attested as referred above at 1.
3. You have to produce 'NOC' at the time of interview from your present employer, if employed in Govt., Semi Govt., PSU, autonomous/statutory bodies and societies (not in case of Private Company) failing which you will not be allowed to appear before the Selection Committee.
4. Outstation candidates attending interview shall be reimbursed 3<sup>rd</sup> AC single to & fro railway fare by shortest route on production of proof of journey or actual fare whichever is less subject to production of NOC as mentioned above (only for candidates called from outside Delhi & NCR).
5. It is once again requested that before attending interview, you may be sure that you fulfill the eligibility criteria in terms of educational qualification and experience advertised for the post. In case, it is found that you do not meet the eligibility criteria for the post, you would not be allowed to appear in the interview and no reimbursement of travelling will be paid in such case.
