Candidates appointed with relaxed qualification shall acquire the minimum academic and professional qualifications laid down in the NCTE's notification dated 23rd August, 2010 as amended from time to time within a period of two years and till they acquire the minimum qualifications as per the NCTE notification, the teachers so appointed under relaxed norms shall be treated as 'trainee teachers'.

Where two or more candidates obtain same weightage(if any), relative position is judged as per notification dated 10.03.2021, of TRBT issued in this regard. Where a reserve category (SC/ST/PH) candidate is recommended against Un-Reserved (UR) Category, the same is indicated in the remarks column. Any appointments made to all the above candidates are subject to the verification of authenticity of mark sheets, documents, certificates etc. submitted by the candidates and validity of their degrees in this regard. If any discrepancy if found by the recruiting department regarding authenticity of mark-sheets/ certificates/ documents or regarding recognition status of Universities/Institutions/Colleges from where degrees are obtained or regarding the validity of academic and professional qualification, the appointment will be cancelled.
